

ORDINANCE NO. 1134, FOURTH SERIES.

AN ORDINANCE AMENDING ORDINANCE NO. 1060, FOURTH SERIES, PASSED JUNE 29, 1945, AND ENTITLED: "AN ORDINANCE APPROPRIATING OUT OF THE REVENUES OF THE FISCAL YEAR COMMENCING JULY 1, 1945, THE AMOUNTS NECESSARY TO MEET THE EXPENDITURES OF THE CITY BASED ON THE BUDGET FOR THE FISCAL YEAR COMMENCING JULY 1, 1945, SUBMITTED BY THE CITY MANAGER, AND MAKING THIS AN EMERGENCY MEASURE," AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: There is hereby appropriated out of the Water Department Surplus Fund the following sums:

SECTION 2: There is hereby appropriated out of the available funds, not heretofore appropriated, the following sums:


- (a) The sum of \$1500.00 to SERVICE AND EXPENSE, Budget No. 3, CITY CLERK.
- (b) The sum of \$150.00 to MATERIALS AND SUPPLIES, Budget No. 23, BUILDING INSPECTION.
- (c) The sum of \$2800.00 to ADDITIONS AND BETTERMENTS, Budget No. 57, RECREATION DEPARTMENT.

SECTION 3: There is hereby appropriated out of the sums heretofore appropriated for Salaries and Wages in Budget No. 34, BACTERIOLOGICAL LABORATORY, the sum of \$150.00 to MATERIALS AND SUPPLIES in said Budget No. 34.

SECTION 4: This ordinance is hereby declared to be an emergency measure and shall take effect immediately, being an ordinance appropriating money.
