POLICE SERGEANT EX. #260

The Board reviewed the scope and content of the written portion of the examination for Police Sergeant. After discussion, it was the order of the Board that the written examination as presented be held on Thursday, May 4, 1950, at 1 P.M. in the Memorial Auditorium.

C. J. Inderbitzen  
Request for reclassification

Communication from F. J. Klaus, City Engineer, requesting that the present classification of

Mr. C. J. Inderbitzen as Foreman General Shop be changed to that of General

Foreman, the latter classification being already established in the salary ordinance, was considered.

It was pointed out that Mr. Inderbitzen has supervision over approximately 21 employees doing work in the Body Shop, Blacksmith Shop, Machine Shop, Police Service Shop and Service Station and that his present salary of \$2.09 per hour was the equivalent of \$4196.42 per year - that amount being from \$600 to \$1300 less than salaries received by Foremen in the Plumbing, Carpenter and Paint Shops.

The results of the survey made by the Civil Service Department were outlined, wherein the salaries of comparative positions with various private companies in the City of Sacramento were found to range from a minimum of \$325 per month to a maximum of \$584 per month.

After reviewing the duties and responsibilities of the incumbent, Mr. Deise moved, seconded by Mr. Hicks, that the request for reclassification to General Foreman be denied. Motion properly passed. Moved by Mr. Deise, seconded by Mr. Hicks, that the Civil Service Board recommend to the City Council that the salary of the Foreman, General Shop, be established on a single monthly basis at a rate of \$400 per month, effective on July 1, 1950. Motion properly passed.
