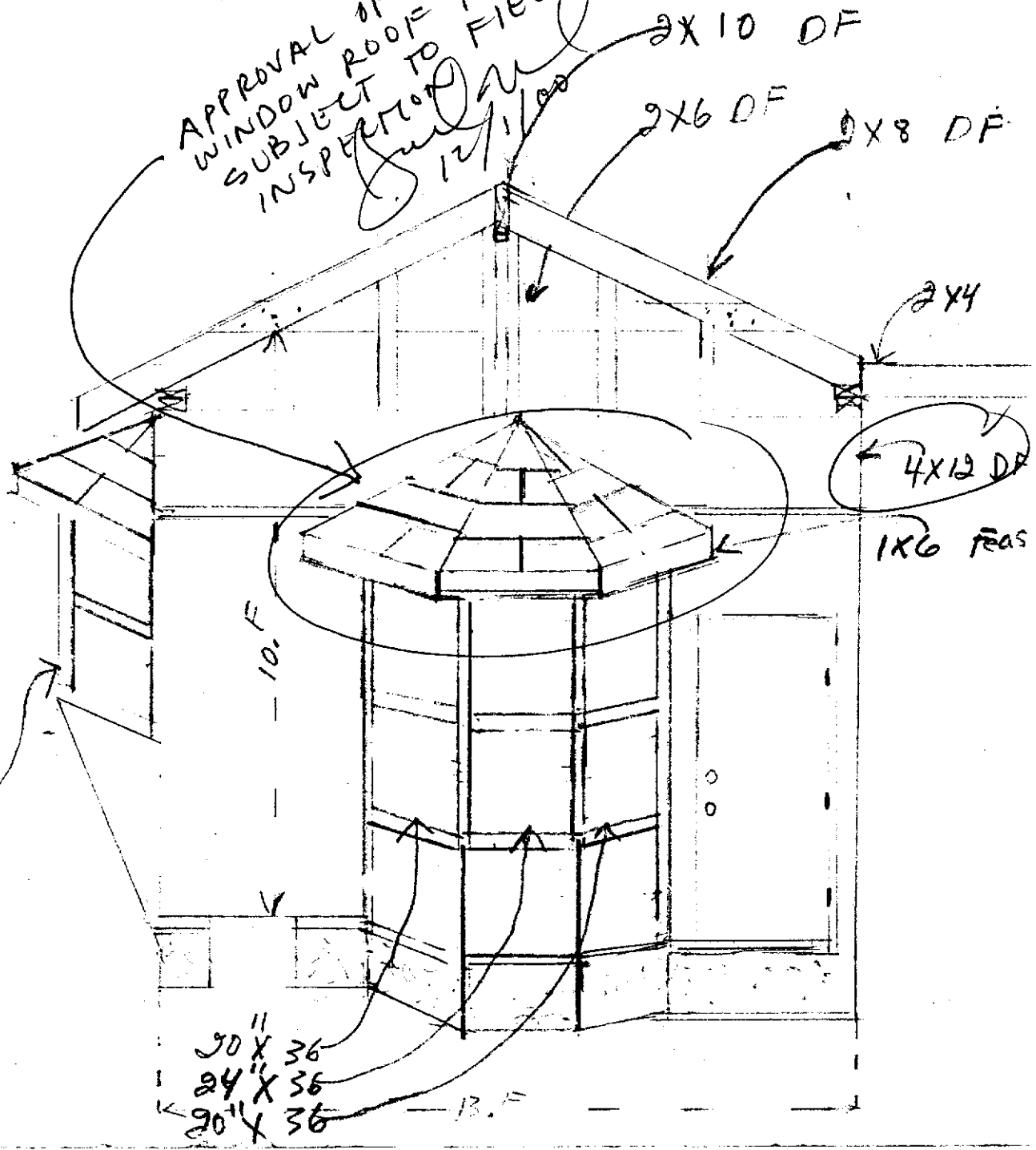

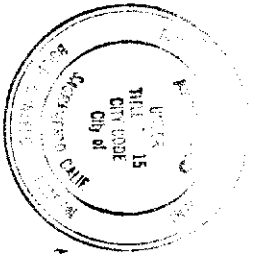

WEST ELEVATION

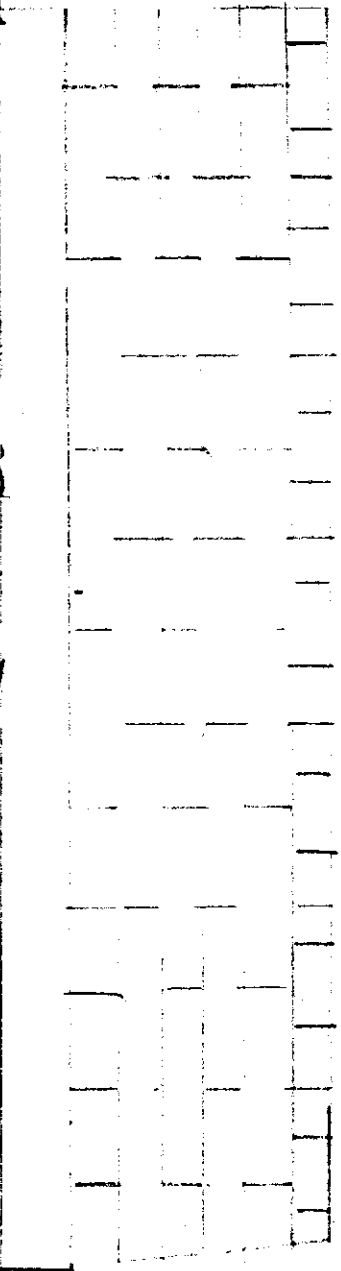

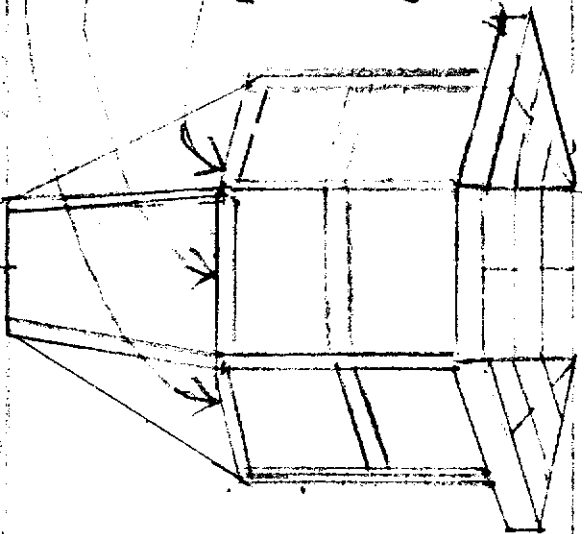
