through the Schematic Design Phase.


RECOMMENDATION

Subject: APPROVAL OF ARCHITECTURAL/ENGINEERING
CONSULTANT SERVICES AGREEMENT FOR EXPANSION OF THE
SACRAMENTO COMMUNITY CONVENTION CENTER (PA11) AND
THE REIMBURSEMENT OF \$5.9 MILLION ADVANCEMENT
BY THE PARKING FUND

SUMMARY

This report requests City Council authorization to enter into an agreement with Vitiello + Associates, Inc. for architectural design and engineering services for the proposed expansion of the Sacramento Community Convention Center located at 1100 14th Street, and for the reimbursement of the \$5.9 million transferred to the Parking Fund from the Community Convention Center Expansion project (PA11).

BACKGROUND

On April 23, 1989, the Department of General Services issued a public notice requesting firms interested in providing architectural/engineering services for the Sacramento Community Convention Center Expansion to submit proposals by June 2, 1990.

One Hundred Fifty-One (151) firms expressed interest in the project and received a copy of the City's Request For Qualifications (RFQ).

On June 2, 1989, eleven firms submitted formal responses to the City's RFQ. From the eleven responses three firms were shortlisted for further investigation and formal interviews.

A technical Staff Committee, consisting of five individuals representing the City Council, City Manager, Community Convention Center, Budget and Finance Department and the Department of General Services reviewed the qualifications of each shortlisted firm on September 6, 1989, and following further research and investigation of each firm, selected Vitiello + Associates, Inc. as the successful finalist.

Negotiations were initiated in November 1989 and resulted in the attached formal agreement.

This contract represents a basic professional services agreement for architectural design and engineering services consistent with prevailing rates associated with similar projects.

Also included is additional compensation for the following special tasks:

1. Civil engineering and street improvements.
2. Life-cycle cost analysis necessary to evaluate alternative heating and air conditioning system designs.

FINANCIAL DATA

The architectural/engineering agreement is divided into the following seven phases:

The consultant's agreement is divided into several discrete phases allowing the City an opportunity to evaluate work completed by the architects and determine if the project should proceed further. Information necessary to evaluate the project will be available upon completion of Schematic Design Phase. Authorization for the architects to proceed through completion of the Schematic Design Phase will require encumbering \$1,033,496.

On January 31, 1989, the City Council approved the transfer of \$5,855,358 from the 1987 COP Category II funds to the Parking Fund as interim financing for the Civic Center Plaza Parking Garage (VA66). Included with the issuance of the 1989 COP on November 14, 1989, was full funding for the garage project; therefore, the Parking Fund may now reimburse those funds transferred from the 1987 COP to the Community Center Expansion project (PA11).

Sufficient funding for activities through completion of Schematic Design Phase will be available through PA11, Fund 419, once funds are transferred from the Parking Fund.

POLICY CONSIDERATIONS

The agreement is structured in a manner whereby the City and consultant agree to a fixed contract limit for the total project. Funding for activities beyond the Schematic Design Phase will be developed and authorized by the City Council as the project progresses. This arrangement is a departure from the previous practice of identifying funding for the total agreement before work begins. Informational reports and requests for authorization will be provided to the City Council at critical stages of the project.

MBE/WBE EFFORTS

The Request For Qualifications issued during the consultant selection process encouraged participation of MBE/WBE in the project and stipulated the City's commitment to substantially increase the utilization of MBE/WBE firms in all City projects. Out of eleven firms that submitted formal responses to the City's RFQ, one firm claimed MBE/WBE status and two firms indicated they would include

MBE/WBE consultants on their teams, but failed to provide any anticipated percentage of distribution. After review of all qualifications, the Technical Staff Committee determined that three firms substantially illustrated the unique ability necessary to design and engineer the project. However, none of the shortlisted firms claimed MBE/WBE status.


RECOMMENDATION

It is recommended that the City Council adopt the attached Resolution authorizing:

1. The City Manager execute an agreement with Vitiello + Associates, Inc. to provide architectural, design and engineering services for expansion of the Sacramento Community Convention Center for an amount not to exceed \$3,969,739;
2. Funding for the consultant to provide architectural, design and engineering services through completion of Phase II Schematic Design, for a sum not to exceed \$1,033,496; and
3. The amendment of the following Capital Improvement Projects by transferring funds as follows:

RESOLUTION AUTHORIZING THE CITY MANAGER TO
EXECUTE AN AGREEMENT WITH
