WHEREAS, the City Council of the City of Sacramento did, on the 13th day of June, 1941, adopt its Resolution No. 2451 entitled "Preliminary Determination of Legislative Body Under 'Special Assessment Investigation, Limitation and Majority Protest Act of 1931,'" under the provisions of Section 2 of said Act;

NOW, THEREFORE, IT IS HEREBY RESOLVED, FOUND AND DETERMINED by said City Council that, after taking the steps provided by Section 2 of said Act above referred to, it is the initial view of this Council that the contemplated improvement described in said Resolution No. 2451 above referred to is one in which the probable assessments will not exceed the limitations set up by said Act above referred to;

RESOLVED, FURTHER, that the Clerk of this Council is hereby ordered and directed to give notice of the contemplated action of this Council by mailing to interested property owners a "Notice of Proposed Assessment" in the time, form and manner, and to the persons, all as provided in Section 13 of said Act above referred to.



RESOLUTION NO. 2451

RESOLUTION OF PRELIMINARY DETERMINATION OF LEGISLATIVE BODY
UNDER "SPECIAL ASSESSMENT INVESTIGATION, LIMITATION AND
MAJORITY PROTEST ACT OF 1931" NO. 2451

BE IT RESOLVED by the City Council of the City of Sacramento that certain improvements are proposed to be done and made within the boundaries of the proposed assessment district hereinafter described.

In connection therewith, said City Council hereby finds and determines as follows, to-wit:

1. That the nature of the proposed improvement and the location and extent thereof consists of improving 7TH AVENUE, from a point 14 feet west of the easterly line of 55th Street, to the sewer in place in 56th Street, approximately 10 feet east of the center line thereof; by removing and disposing of all surplus and refuse material; constructing concrete curbs, gutters and sidewalk; installing cast iron gutter drains; constructing vitrified ironstone pipe sewer; installing concrete manholes; placing street monument; grading; and constructing an asphaltic concrete pavement five and one-half ($5\frac{1}{2}$) inches in thickness with seal coat and screenings.

2. The boundaries of the district of lands proposed to be specially assessed to pay the costs and expenses of such proposed work and improvement are generally defined as follows, to-wit:

On the north by the northerly boundary of "Gibson Tract" (as the same is shown on the official map or plat thereof filed in the office of the County Recorder of the County of Sacramento, State of California); on the east by 56th Street; on the south by the southerly boundary of said "Gibson Tract;" and on the west by the westerly boundary of said "Gibson Tract."

3. That the amount and portion of the cost of such proposed improvement proposed to be paid by the City of Sacramento from any source other than special assessments upon benefited property is nil.

4. The statute under which it is proposed to conduct proceedings for the proposed improvement is the "Improvement Act of 1911," approved April 7, 1911, and the several acts amendatory thereof or supplemental thereto; with bonds to be issued as authorized under the "Improvement Bond Act of 1915," approved June 11, 1915, and the several acts amendatory thereof or supplemental thereto, said bonds to bear interest at the rate of five (5%) per cent per annum; ~~and~~


~~BE IT FURTHER RESOLVED that the City Engineer is hereby directed to prepare for this Council a written Report upon the proposed improvement, such Report to contain all the information required by Section 3 of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931," approved June 8, 1931, and the several acts amendatory thereof or supplemental thereto.~~

in the City of Sacramento, be, and the same are, hereby approved and adopted;


BE IT FURTHER RESOLVED that the grades as shown on said plans be, and the same are, hereby adopted as the official grades; and

RESOLUTION APPROVING MAP AND DIAGRAM NO. 2451


