PROJECT EVALUATION: Staff has the following comments:

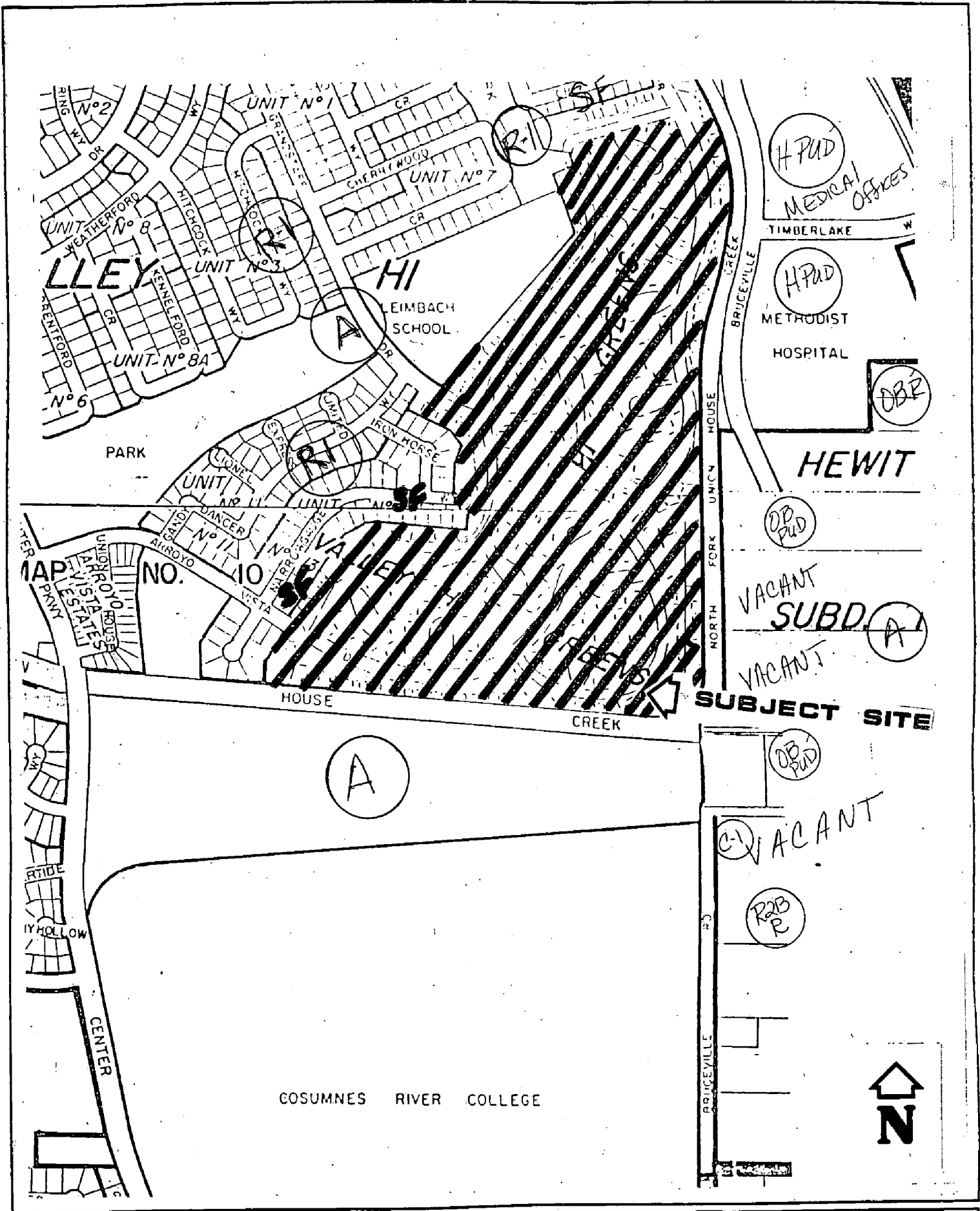
- A. The subject site consists of five vacant parcels totaling 78.2+ acres in the Single Family Alternative (R1A) zone. The General Plan designates the site as low density residential (4-15 du/ac). The 1986 South Sacramento Community Plan designates the site as residential (4-8 du/ac). The surrounding land uses and zones are: North-single-family; R-1, south-Cosumnes River College; A, east-hospital, medical offices, vacant; H(PUD), OB(PUD), A, OB, C1, and R2B(R) and west - single family, school, and park; A and R-1.
- B. The applicant proposes to merge five parcels into two for future sales and development. The applicant has filed an application for Parcel 2, the southern portion. The applicant proposes to develop Parcel 2 with single family, multi-family, and office buildings (P89-255).

C. The lot line merger was reviewed by Traffic Engineering, Engineering Development Services, Electrical Engineering, and Real Estate; the following comments were received:

1. Applicant shall complete the following at the Public Works Department, Development Services Division, prior to lot line merger being recorded:
 - a. File certificate of compliance, submit all required documents according to the submittal requirements checklist, and pay necessary fees.
 - b. File a waiver of parcel map.
 - c. Pay off or segregate any existing assessments.

ENVIRONMENTAL DETERMINATION: This project is exempt from environmental review pursuant to State EIR Guidelines (CEQA Section 15305a).

RECOMMENDATION: Staff recommends the Planning Commission approve the lot line merger by adopting the attached resolution.

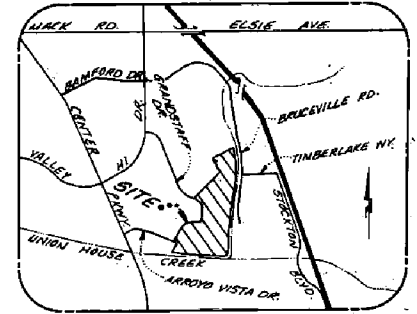
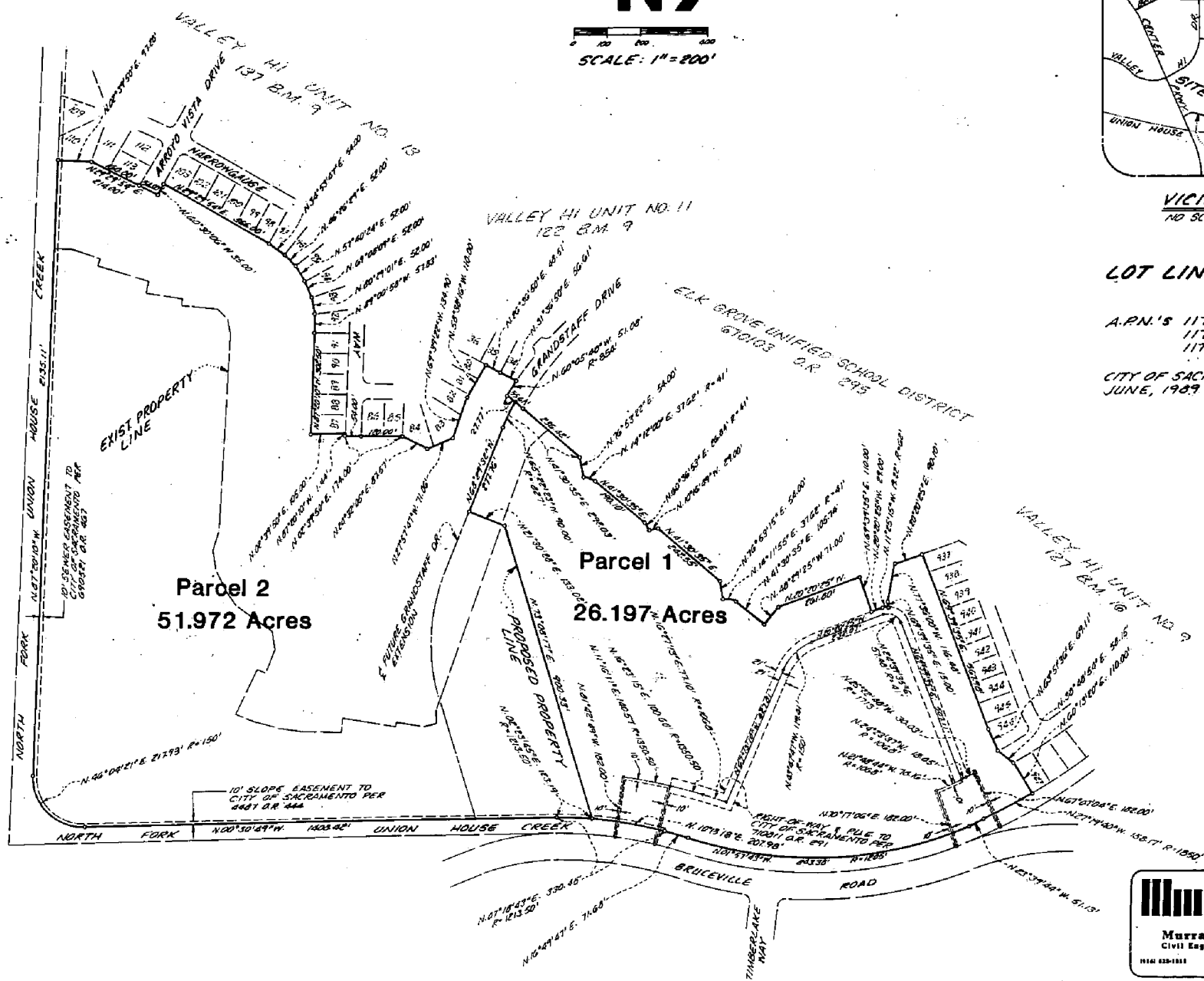


VICINITY - LAND USE - ZONING
