## MINUTES

David Melko, Planning and Development Department, reviewed this item. In 1988 traffic and circulation for the North Natomas area were re-evaluated. Currently, 15,000 to 17,000 vehicles daily will use the roadway between North Market Blvd and Arco Arena Blvd. Staff feels that in this area 4 lanes instead of 6 are adequate.



Council member Fargo voiced concerns about traffic impact in peak hours during the morning and evening commute hours. Staff responded that levels of service at those times remains at Level E according to the Transportation Division.

Council member Kastanis asked if portions of the road would remain 6 lanes, and if this would cause traffic load inconsistencies. Staff responded that there would be 6 lanes west of Truxel Road to East Commerce, and that levels of service are adequate where the four lanes occur. Traffic flow patterns will take care of the loads.

Council member Fargo MOVED, Council member Pane SECONDED, forward to Council.
