Government Code 54950 (The Brown Act) requires that a brief description of each item to be transacted or discussed be posted at least 72 hours prior to a regular meeting. The City posts Agendas at City Hall as well as offsite meeting locations.

The order of agenda items is for reference only; agenda items may be taken in any order deemed appropriate by the Commission. The agenda provides a general description and staff recommendations; however, the Commission may take action other than what is recommended. The agenda is available for public review on the **Monday** prior to the meeting. 

Jonathan Rewers, Parks and Recreation Analyst, conducted a workshop to review this item. The presentation was for the purposes of going through the Park Safety Audit process on nine identified parks sites in need of safety improvement action plans. The park sites included: Hagginwood Park, Gardenland Park, Johnston Park, Chorley Park, McClatchy Park, Ninos Park, Strawberry Manor Park, Martin Luther King Jr. Park, and Bill Bean Park. The Park Safety Audit focused on the following issues at each of the nine parks: general condition, design, use, maintenance, visibility, and safety. Commissioners participated in a park safety audit questionnaire on all nine park facilities to identify issues and provide recommendations for possible improvements. Staff will compile the data to finalize recommendations and report back to the Commission in March.
