**Recommendation:** Adopt a **Resolution:** 1) approving Plans and Specifications for the South Watt Avenue / Fruitridge Road Traffic Signal and Intersection Improvements Project (TR91 / T15058800); and 2) awarding the contract to Teichert Construction in an amount of \$824,081.

### Description/Analysis

**Issue:** The project consists of installing a traffic signal, widening South Watt Avenue at Fruitridge Road, installing new curb ramps, placing a slurry seal, and restriping the intersection. Bids were received and Teichert Construction is the lowest responsive and responsible bidder. City Council approval is necessary to move forward with awarding a construction contract.

**Policy Considerations:** This action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of achieving sustainability and neighborhood livability.

**Environmental Considerations:**

**California Environmental Quality Act (CEQA):** Projects exempted under Class 3, Section 15303 consists of new construction and location of new, small structures or facilities. Project exempted under Class 3, Section number 15303(d) consists of new construction of water main, sewage, electrical, gas, and other utility extensions, including street improvements to serve such construction. Projects exempted under Class 4, Section 15304(f) consists of minor trenching or backfilling where the surface is restored.

The Development Services Department, Environmental Planning Services Division has reviewed this project and determined that is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 3, Section 15303, Class 3, Section 15303(d) and Class 4, Section number 15304(f).

**Sustainability Considerations:** This project is consistent with the City's Sustainability Master Plan. It conforms to the Air Quality Focus Area by improving and optimizing transportation infrastructure.


**Other:** None.

**Rationale for Recommendation:** Teichert Construction is the lowest responsive and responsible bidder.


**Financial Considerations:** As of June 19, 2008, the South Watt Avenue / Fruitridge Road Traffic Signal and Intersection Improvements Project (TR91 / T15058800) has an unobligated balance of \$1,325,700 which is sufficient to execute the contract with Teichert Construction in the amount of \$824,081 and cover construction management costs.

**Emerging Small Business Development (ESBD):** Teichert Construction meets the City's 20% ESBE goal. To encourage small and emerging business participation, plans and specifications were sent to fifteen (15) plan rooms and construction service organizations for publication. All are directly involved with ESBE construction firms. Staff actively recruited available ESBE firms to participate in the bid process. Project notices were sent to four organizations involved in ESBE recruitment. **Background Information:**

The project consists of installing a traffic signal, widening South Watt Avenue at Fruitridge Road, installing new curb ramps, placing a slurry seal, and restriping the intersection.

On November 14, 2006, the City Council approved Cooperative Agreement No.2006-1329 between the City of Sacramento and the County of Sacramento to signalize the intersection, improve efficiency, and reduce traffic congestion. The City is contributing \$450,000 and the County is contributing the remaining funds necessary to complete the project. The total project cost is estimated to be \$1,225,000.

The project was advertised and bids were received on June 4, 2008. The bids are summarized below:

The engineer's estimated construction cost was \$996,238. Contract award to Teichert Construction is recommended as the lowest responsive and responsible bidder. Construction is anticipated to start in summer of 2008 and to be completed by fall of 2008.
