

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

November 27, 1933.

The Civil Service Board met in special session in the office of the Board, Room 106, City Hall, at 8:00 o'clock P.M., President Weisman presiding.
