#### **MINUTES:**

Patricia Mendoza, Associate Planner, presented this item to the Committee, which is an analysis of the August 8 version of AB 51. She explained that the original bill had been significantly amended at the Legislature, and that at the present time staff is proposing a vote of support some of the bill's ideas, in concept only. She noted that this bill no longer contains anything relating to no-net housing loss provisions, and that the bill would allow jurisdictions, if they haven't already adopted a housing ordinance, to self-certify if they meet certain conditions. She reviewed the staff report and passed out some tables (attached). Patricia Mendoza, Dianne Guzmann, Planning and Development Director, Gary Stonehouse, Planning Director, and Marc Brown answered questions from the Committeemembers and elaborated on the bill as amended. There was considerable discussion.

Kastanis moved to support in concept AB 51, with the provisions discussed that go along with these concepts. Steinberg seconded the motion, and it was unanimously supported.

The meeting was adjourned at 1:30 p.m.
