SUBJECT: SALARY REVISION - ENERGY SYSTEMS COORDINATOR

SUMMARY

This report recommends that the City Council take action to increase the salary level of the Energy Systems Coordinator classification in order to attract a qualified individual and to align it internally with other City classifications.

BACKGROUND

The current salary level for the vacant Energy Systems Coordinator position is \$2449.37 to \$2977.35 per month. This salary range was based upon external salary data from the City's survey jurisdictions. In order to attract a qualified individual to perform the Energy Systems Coordinator's duties, the City Manager believes that a higher salary, based upon internal alignment, is necessary.

The one-position Energy Systems Coordinator classification is assigned to the General Services Department and reports directly to the Director of General Services. A salary based upon internal alignment within the General Services Department would most appropriately be \$2705.73-\$3288.65 per month. This is the same salary as the Fleet Superintendent and Support Services Administrator, which also report directly to the Director, and are in the General Management Unit. Some of the other management classes in the City with this salary range are: Assistant Street Maintenance Superintendent; Assistant Traffic Engineer; and Chief Building Inspector.

FINANCIAL DATA

The new recommended salary range for Energy Systems Coordinator is \$2705.73-\$3288.65 per month, which is 10.455% higher than the current salary range. Salary savings would offset, for the remainder of the year, the approximately \$310 per month salary increase.

RECOMMENDATION

It is recommended that the City Council approve the attached resolution which revises the salary schedule for the new classification of Energy Systems Coordinator.
