SUBJECT: Approval of Agreement For Reimbursement For
Country Scene Commercial (Franklin Boulevard
and Mack Road), Improvement Proceeding No. 4964

BACKGROUND INFORMATION

As a consideration of the approval of the subdivision map for Country Scene Commercial, a private contract was required for the construction of the subdivision improvements. The owners of the property have executed a contract with C. V. O'Neill, Inc. for the construction of said improvements.

The construction of Franklin Boulevard and Mack Road are major arterials and call for City participation in their construction. The City's share, based on the bid prices, is \$22,831.38.

FINANCIAL DATA

Funds for the City's portion (\$22,831.38) will be paid out of the City Engineers Budget No. 2-09-2600-2403-4820 when the funds become available and according to where this particular project appears on the priority list established by the City Engineer.

RECOMMENDATION

It is recommended that the attached Resolution be adopted which authorizes and directs the City Manager and City Clerk to execute an Agreement For Reimbursement.

AUTHORIZING AND DIRECTING THE CITY MANAGER AND CITY CLERK TO EXECUTE AN AGREEMENT FOR REIMBURSEMENT FOR COUNTRY SCENE COMMERCIAL, APPROPRIATE OUT OF MAJOR STREET CONSTRUCTION FUND THE SUM OF \$22,831.38, AND AUTHORIZING AND DIRECTING THE DIRECTOR OF FINANCE TO EXPEND SAID SUM

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Manager and City Clerk are hereby authorized and directed to execute an Agreement For Reimbursement between the City of Sacramento and Wincorp Industries Inc. for the City Contribution (\$22,831.38) for extra width street section required for Franklin Boulevard and Mack Road in Country Scene Commercial.

BE IT FURTHER RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the sum of \$22,831.38 is hereby appropriated out of Major Street Construction Fund's available fund balance to the City Engineer's Budget No. 2-09-2600-2403-4820 and the Director of Finance be, and he is hereby authorized and directed to expend said sum.
