SUBJECT: Consultant Services Contract with the State of California,
Office of Criminal Justice Planning

SUMMARY

The Sacramento Police Department has responded to a request by the Office of Criminal Justice Planning to provide a Law Enforcement Consultant for a 12-month period beginning December 28, 1981. It is proposed that Officer Mathew Powers be permitted to fulfill the requirements of this one-year contract.

BACKGROUND INFORMATION

Historically, the State of California solicits and contracts for the services of local law enforcement agency employees. A similar contract is presently in effect with California Youth Authority for the services of Lieutenant Phillip York.

For the current solicitation, it is requested that Officer Mathew Powers be permitted to perform this service. As the Law Enforcement Consultant, he will be working on the Career Criminal Apprehension Program (CCAP). Responsibilities would include developing training programs for new CCAP grants awarded to local law enforcement agencies, integrating numerous federal manuals into a usable working manual, and review of project reports. Additionally, Officer Powers will be travelling to various agencies throughout the state to provide on-site evaluation of CCAP programs.

FINANCIAL IMPACT

The authorization to proceed with this endeavor will necessitate augmentation of the departmental budget for Fiscal Year 1981-82. Full-time sworn positions must be increased by one position (officer) for the 12-month period and employee services costs must be increased by \$39,017. The cost of future fiscal years will be included in the budget submitted for each of those periods. All anticipated costs for this program will be offset by a corresponding increase



in revenue from the Office of Criminal Justice Planning for each period. The estimated total value of the contract is \$39,017.

RECOMMENDATION

It is recommended that this department and the City of Sacramento be permitted to enter into an agreement with the Office of Criminal Justice Planning to provide the services of Officer Mathew Powers as a Law Enforcement Consultant, that the City Manager be authorized to sign a contract for these services, and that the departmental budget be augmented to provide for the increased cost.

A RESOLUTION AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE OFFICE OF CRIMINAL JUSTICE PLANNING TO PROVIDE TO THAT AGENCY THE SERVICES OF A LAW ENFORCEMENT CONSULTANT AND TO AMEND THE POLICE DEPARTMENT BUDGET FOR FY 1981-82

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

The Sacramento Police Department desires to provide the services of a Law Enforcement Consultant to the Office of Criminal Justice Planning for the purpose of providing technical assistance to California law enforcement agencies and aiding in the development and administration of the Career Criminal Apprehension Program.

In the event said agency consents to contract for such services, the City Manager is authorized, on behalf of the City Council, to execute a one (1) year contract.

The Sacramento Police Department budget for Fiscal Year 1981-82 is to be increased by \$39,017. Appropriations in this amount are to be credited to Account 1-01-1710-5183-41xx.

The source of funds shall be the Administrative Contingency Fund of the General Fund, Account 1-01-5070-0000-4399.

Revenues from said contract with the Office of Criminal Justice Planning shall be deposited to the General Fund Account 1-01-0000-5183-3608.
