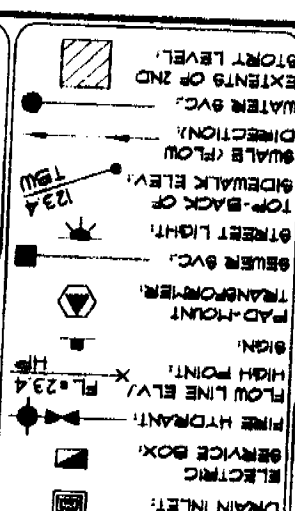
EXISTING NORTHPOINTE PARK VILLAGE 30A
