

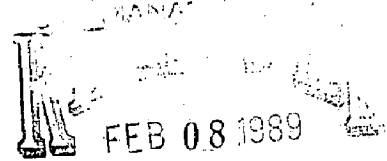



SUBJECT: AUTHORIZATION TO (1) SUBMIT AN APPLICATION FOR 50 SECTION 8 HOUSING VOUCHERS FOR THE CITY OF SACRAMENTO, AND (2) TO EXECUTE THE ANNUAL CONTRIBUTIONS CONTRACT RESULTING FROM THE APPROVAL OF THE APPLICATION.

SUMMARY

Authorizes the Executive Director to (1) apply for 50 Section 8 Housing Vouchers; and (2) to execute the Annual Contributions Contract (ACC) resulting from the approval of the application.

BACKGROUND

On January 19, 1989, the U. S. Department of Housing and Urban Development invited the Agency to apply for 50 Section 8 Housing Vouchers for the City of Sacramento.

The application will request funding for twenty (20) three-bedroom, twenty (20) four-bedroom; and ten (10) five-bedroom Vouchers.

The Agency typically is invited to apply for new units of available housing assistance each year. If the application is approved, these Housing Vouchers would be targeted to assist eligible families from the Section 8 waiting list. Approval of the attached resolution will authorize the Executive Director to apply for the Vouchers above and to execute the related ACC should the application be approved.

FINANCIAL DATA

Although the resolution will authorize the Executive Director to apply for Vouchers and to execute the related ACC if the application is approved, he will not be authorized to amend the Agency budget to incorporate additional revenues and expenditures generated by the new ACC. The Executive Director will need a separate resolution to do so.

Until the application is approved, the exact dollar level of assistance cannot be determined at this time. However, the application is requesting annual Contract authority in the amount of \$388,660, and a 5-year Budget Authority in the amount of \$1,943,300.

ENVIRONMENTAL REVIEW

No environmental review is required for this activity.

POLICY IMPLICATIONS

The actions proposed in this staff report are consistent with previously approved policy and there are no changes being recommended.

MBE/WBE EFFORTS

MBE/WBE considerations are not required with this activity.

VOTE AND RECOMMENDATION OF COMMISSION

It is anticipated that at its meeting of February 13, 1989, the Sacramento Housing and Redevelopment Commission will adopt a motion recommending that you take the above mentioned action. In the event they fail to do so, you will be advised prior to your February 14, 1989 meeting.


