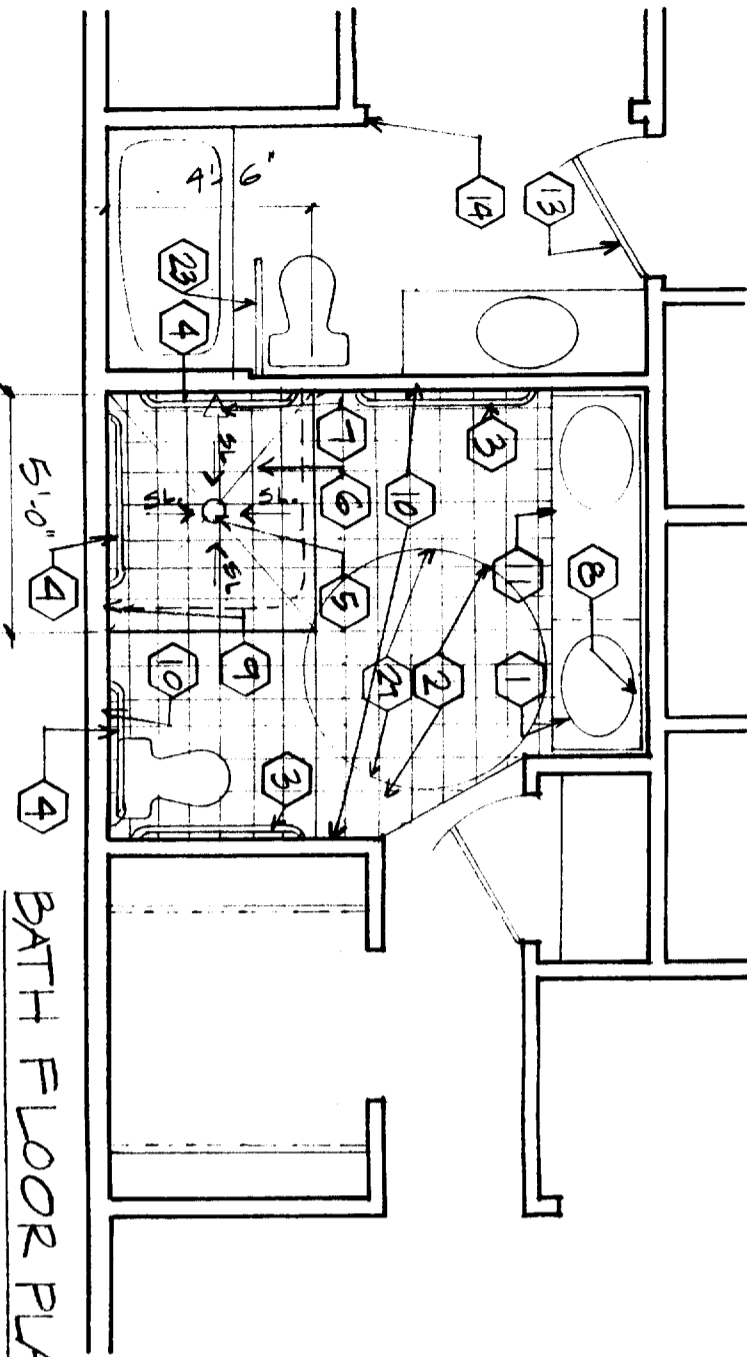

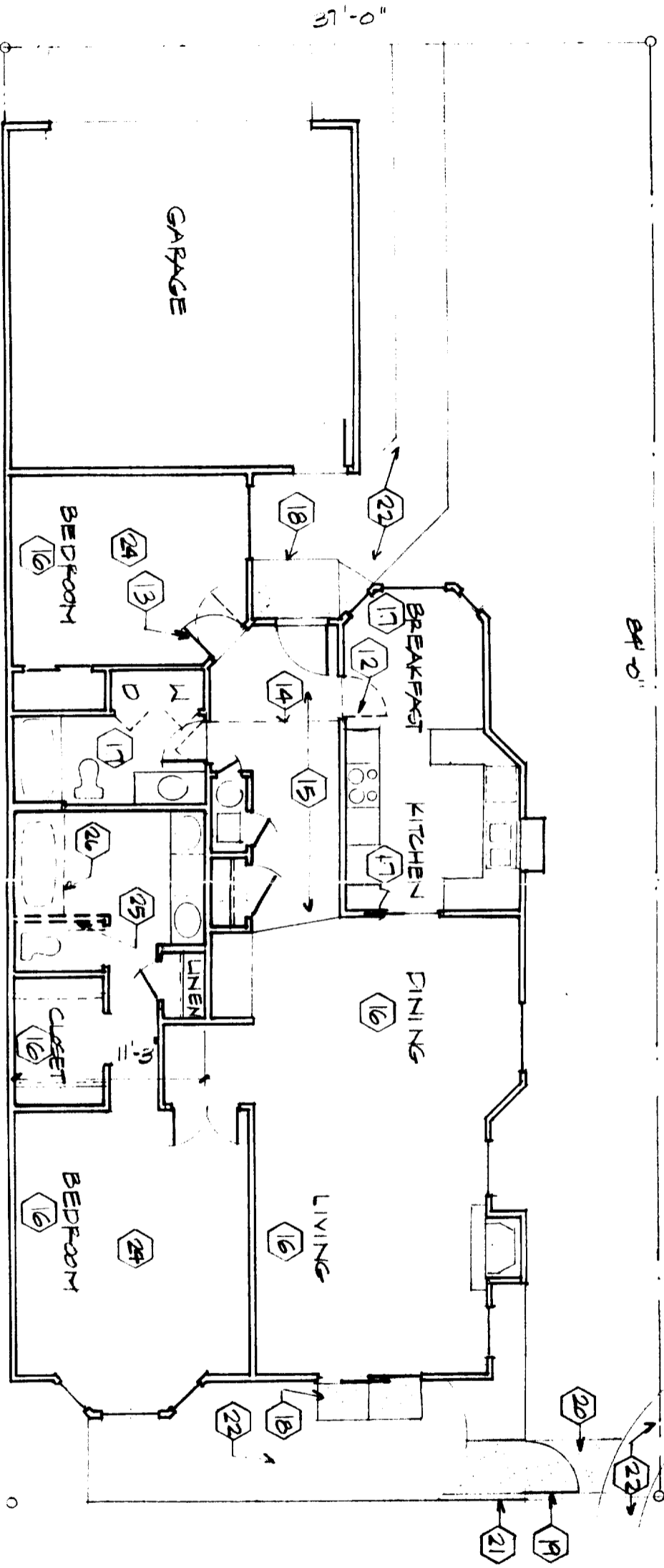


BATH FLOOR PLAN
