The purpose of this correspondence is to advise you that the Sacramento Police Officers Association hereby expresses no opposition to the administration of the upcoming Lieutenant's Promotional Examination by the use of evaluation of candidates through assessment centers. The fact that the SPOA has no opposition to the use of such centers is solely limited to the aforementioned Lieutenant's Examinations due to its experimental nature.

However, the SPOA by entering into this new and innovative program by no way wishes to waive any further rights in regards to other examinations or procedures within the purview of Section 3504 of the Government Code.

RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE


Rodney C. Hilaman - Appeal
