SUBJECT: ESTABLISHMENT OF CIPS AND THE APPROPRIATION OF MATCHING

AND START-UP FUNDS FOR APPROVED TRANSPORTATION EQUITY

ACT OF THE 21<sup>ST</sup> CENTURY (TEA -21) PROJECTS

LOCATION/COUNCIL DISTRICT: Citywide. All Districts.

This report recommends that the City Council adopt the attached resolution which amends the FY 2000/2001 Capital Improvement Program Budget to appropriate matching and start-up dollars to approved grant funded (TEA-21) projects.

#### **SUMMARY:**

Staff requests that the Council approve appropriations in the amount of :

- \$134,037 from the State and Federal Grant Match project (TX01) to the Infill Sidewalks (RJ66), Midtown South SMART (TS43) and 65<sup>th</sup> Street Improvements, 14<sup>th</sup> Avenue to the City Limits (TY06);
- \$23,000 from the Planning Division's operating budget to the 65<sup>th</sup> Street Transit Village Planning Study (TY21); and

 \$29,616 from Los Rios Community College District to the Sutterville and 23<sup>rd</sup> Street Intersection Improvement project (TX91).

These allocations will cover staff costs associated with starting these projects and the matching funds required for preliminary engineering.

## **COMMITTEE/COMMISSION ACTION: None.**

### **BACKGROUND INFORMATION:**

On January 18, 2001, SACOG approved TEA-21 Phase 2 projects. Staff is requesting that Capital Improvement Projects (CIP) for some of the approved projects be established now. The CIPs for the remaining projects will be established as part of the FY 2001/2002 Capital Improvement Program when the matching funds for those projects are available.

#### FINANCIAL CONSIDERATIONS:

Staff is requesting a total amount of \$134,037 from the State and Federal Grant Match project (TX01) to cover grant funded project start-up and matching funds. The available balance in this project is \$1,738,944, which is sufficient to cover this request. Acceptance of \$29,616 from Los Rios Community College District will provide start-up and matching funds for Sutterville and 23<sup>rd</sup> Intersection Improvement project (TX91). Staff is also requesting \$23,000 from the Planning Division operating budget to cover start-up and matching funds for the 65<sup>th</sup> Street Transit Village Planning Study (TY21).

Staff is also requesting the establishment of a new CIP for the Stockton Streetscape, El Paraiso Avenue to Riza Avenue (TY51) and the transfer of \$60,000 from the Stockton Boulevard Streetscape, Fruitridge Road to El Paraiso Avenue (TU72). Staff is requesting that the streetscape enhancement project be separated into two segments and two CIPs.

## **ENVIRONMENTAL CONSIDERATIONS:**

The subject of this report does not involve a project, which requires compliance with the California Environmental Quality Act (CEQA), in as much as it does not involve an activity, which may cause a direct or indirect change in the environment (Public Resources Code Section 21065).

## **POLICY CONSIDERATIONS:**

The attached resolution is consistent with City Council's goal of leveraging local funds to obtain state and federal funding to deliver key transportation improvements, and in investing local funds to ready projects for future state and federal grant cycles.

## THE CITY COUNCIL OF THE CITY OF SACRAMENTO RESOLVES THAT:

- 1. The FY 00/01 Capital Improvement Program (CIP) be amended to include the following grant funded projects:
  - Infill Sidewalks (RJ66)
  - 65<sup>th</sup> Street Improvements, 14<sup>th</sup> Avenue to the City Limits (TY06)
  - Sutterville and 23<sup>rd</sup> Street Intersection Improvements (TX91)
  - 65<sup>th</sup> Street Transit Village Planning Study (TY21)
  - Stockton Streetscape, El Paraiso to Riza (TY51)
- 2. The FY00/01 Capital Improvement Program (CIP) be amended by allocating:
  - \$134,037 from the State and Federal Grant Match (TX01) to the Infill Sidewalks (RJ66), Midtown South SMART (TS43) and 65<sup>th</sup> Street Improvements, 14<sup>th</sup> Avenue to the City Limits (TY06).
  - \$23,000 from the Planning Division operating budget to 65<sup>th</sup> Street Transit Village Planning Study (TY21).
  - \$29,616 from the Los Rios Community College District to the Sutterville and 23<sup>rd</sup> Street Intersection Improvements (TX91).
