

RESOLUTION APPROVING REPORT AND AMENDED

ASSESSMENT NO. 2598

WHEREAS, a petition for an Amended Assessment of a certain parcel s of land in that certain Street Improvement Proceeding Numbered, RESOLUTION OF INTENTION NO. 2598 for the construction of

a District Sewer in Right-of-Ways owned by the City of Sacramento along Burns Slough from 41st Street to the Southern Pacific Right-of-Way; thence to the Southwest corner of River Park (as the same is shown on the official Plat thereof filed in the office of the Sacramento County Recorder)

in the City of Sacramento, was filed with the City Council of the City of Sacramento under the provisions of Streets and Highways Code Sections 8730 to 8734 inclusive, and

WHEREAS, the City Council of the City of Sacramento duly and regularly directed the Superintendent of Streets, to file his Report and Amended Assessment together with a Map showing how said parcel s of land ha ve been subdivided, and

WHEREAS, E. A. Fairbairn, Superintendent of Streets, filed with the City Clerk a Report and Amended Assessment together with a Map showing how said parcel s ha ve been subdivided, and


WHEREAS, the Clerk pursuant to the provisions of said Streets and Highways Code, did duly and regularly give notice of the filing of said Report and the fixing of a time for hearing objections to the Report and the Amended Assessment and Map so filed, and

WHEREAS, said Report, Amended Assessment and Map are now on for hearing at the meeting held this 31st day of May, 1956, in the Council Chambers of the City Council of the City of Sacramento, and

WHEREAS, no written protests were filed to the same or did anyone appear in person and protest the same.

NOW, THEREFORE BE IT RESOLVED, that notice of this hearing was given in the manner and for the time provided by law, and that the Report and Amended Assessment of E. A. Fairbairn, Superintendent of Streets, filed with the City Clerk on May 11th, 1956, ~~18~~ apportioning Assessment Number s 587, 588 and 833 in Street Improvement Proceedings No. 2598 according to the benefits to the several parts of the lands originally affected by said Assessment Number s 587, 588 and 833 into eight ( 8 ) parcels, be, and the same is hereby approved and confirmed, and that the City Clerk file said Amended Assessment with the Auditor of the City of Sacramento and that collections of unpaid installments of said Original and Amended Assessment, shall be made in accordance therewith as provided by Law.
