- Approve Plans and Specifications and authorize the City Clerk to advertise and receive bids for Bridge 17 & 18 Replacement at Haggin Oaks Golf Course.

**SUMMARY:**

Bridges 17 & 18 at Haggin Oaks Golf Course require replacement due to their severe structural deficiencies and deteriorated condition. This report requests ratification of the Environmental Impact Report Negative Declaration and authorization to advertise and receive bids for this project.

## **BACKGROUND INFORMATION:**

On February 9, 1993, City Council authorized the City Manager to enter into two separate Consultant & Professional Services agreements with JTS Engineering Consultants, Inc. (an MBE). One agreement is for Bridge #17 & #18 replacement (OA61). The second is for Bridge #13/Culvert repairs at Haggin Oaks Golf Course (OA81). Plans and Specifications for Bridge 17 & 18 replacement (OA61) has been completed and the project is ready to bid.

Staff will report back to Council on the status of Bridge #13/Culvert repairs (OA81) project April of 1994.

Under the California Environmental Quality Act of 1970, an initial study was completed on July 16, 1993. As a result of this study, the Environmental Coordinator has determined that the replacement of Bridges #17 & #18 will not have a significant adverse impact on the environment and a negative declaration was prepared.

A Notice of Availability for public review and comment of negative declaration was published in a local newspaper on July 17, 1993. The appropriate length of time has elapsed for comments regarding the negative declaration. Modifications or revisions which respond to the comments made have been incorporated into the construction bid packages.

## **FINANCIAL CONSIDERATIONS:**

Sufficient funds are available in CIP OA61 to cover the estimated cost of \$192,000 for Bridge #17 & #18 Replacement at Haggin Oaks Golf course. A non refundable fee of \$25.00 will be charged for Plans & Specifications.

## **POLICY CONSIDERATIONS:**

Approval of a Resolution ratifying the Negative Declaration and approval of the plans and specifications for Replacement of Bridges #17 & #18 at Haggin Oaks Golf Course is consistent with Sacramento City Code.


