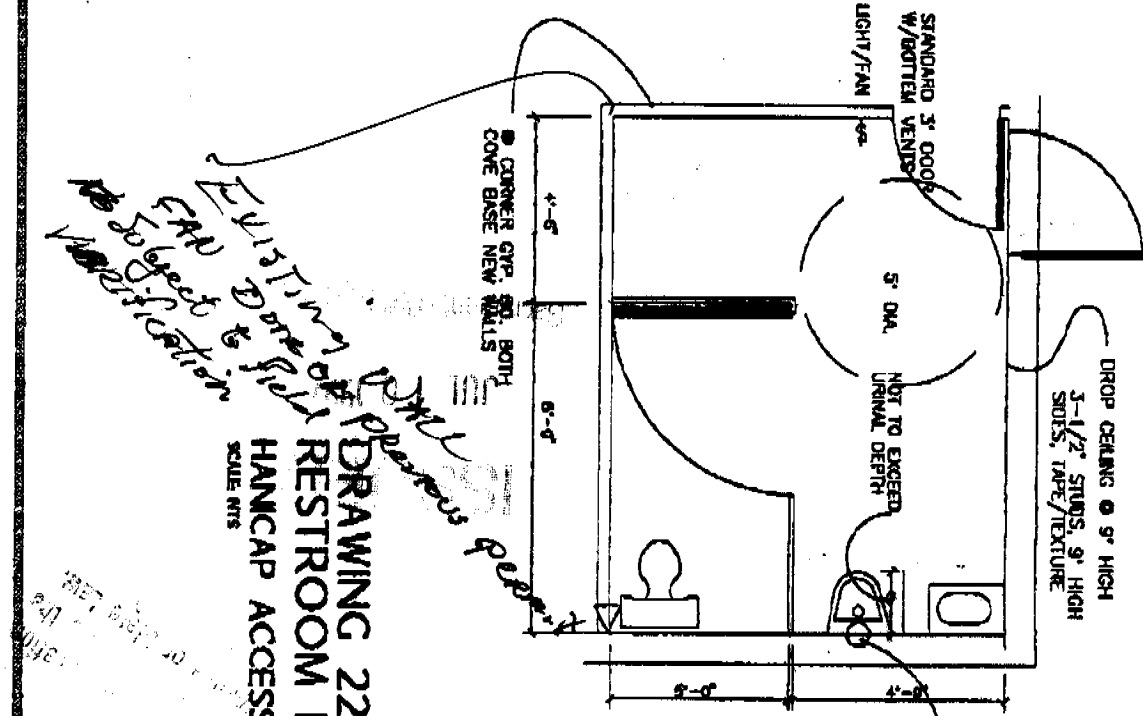

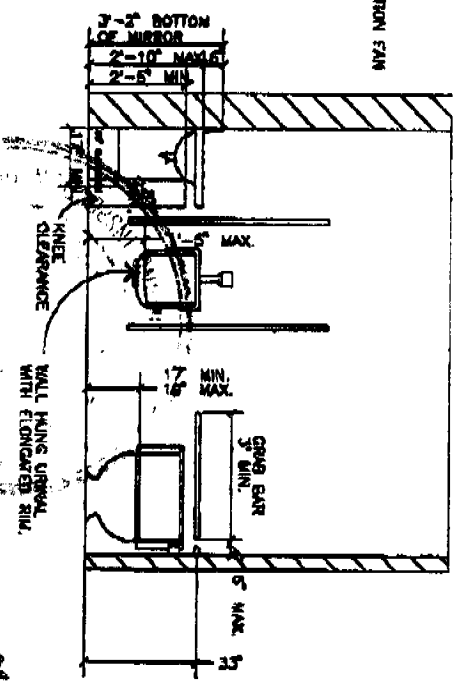

SCALE: A1/8"



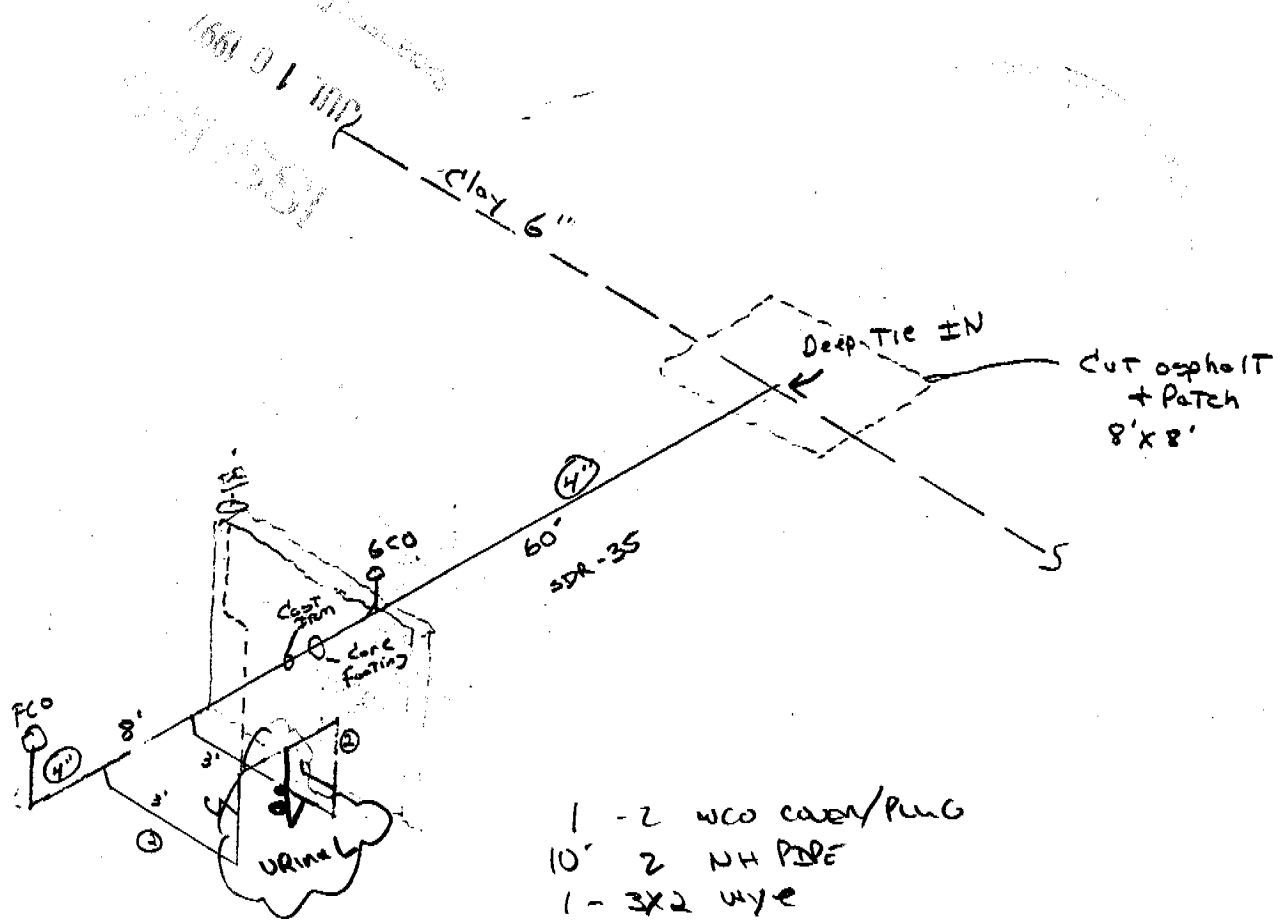
SOUTH ELEVATION
