1.1 Legislative Update

2.0 STAFF REPORTS

2.1 An Ordinance amending Title 25, Chapter 1, Section 25.01.019-1 of the Sacramento City code relating to Radios in Vehicles

Recommendation of Staff: Approve Staff Recommendation and Forward to City Council

Committee Action: Approved Recommendation and Forwarded to City Council

Jane Christenson, Administrative Analyst - Police dept., the purpose of the proposed ordinance is to increase fines for violations related to loud music emanating from radios in vehicles. The fees currently in place have been insufficient to deter this activity. The intent is to raise fines for this offense on par with those for cruising, since these two offenses are often cited together.

Sgt. Smythe, Police Dept., said that the Police dept. has been getting a lot of complaints from citizens about the loud music from vehicles. The intent is to target those vehicles whose music you can hear 2 to 4 blocks away.

A motion was made by Committee Member Steinberg, seconded by Committee Member Waters to approve staff recommendation and forward to city council for full review. The motion carried with a 3-0 vote.

2.2 An Ordinance amending Sections 2-B-9 and 2-C-30 of the Comprehensive Zoning Ordinance (Ordinance No. 2550, Fourth Series, as amended) Relating to Residential Care Facilities and Non-Residential Care Facilities in the Hospital (H) Zone

Recommendation of Staff: Approve Staff Recommendation and Forward to the Planning Commission

Committee Action: Approved Recommendation and Forwarded to the Planning Commission

Dianne Guzman, Director, Planning and Development, this matter was previously heard by the City Council as an emergency ordinance. The action was to refer this to the Law & Legislation Committee as a regular ordinance. Recommendation is to change the

residential and non-residential care facilities to require a special use permit as opposed to permitting by right. If this ordinance is recommended the Planning Dept. asks that it only be in place until the more comprehensive changes to the zoning ordinance come out in the Social Service Vocational Study.


Committee Member Steinberg, asked if passage of this ordinance would affect Aquarian Effort's ability to locate in their proposed location. Ms. Guzman said, "probably not, it depends upon how quickly they are in escrow on the property".

A motion was made by Committee Member Steinberg, seconded by Committee Member Waters to approve recommendation and forward to the Planning Commission for full review. The motion carried with a 3-0 vote.


**ADJOURNED** - There being no further business to come before the Law & Legislation Committee, the meeting was adjourned at the hour of 12:30 p.m.
