This bill would make it a policy of the state, in selecting locations to lease or construct buildings for the conduct of state business, to give consideration to the community to be served by the facility, the nature of the state tenant agency's programs, facility requirements, the goal of minimizing state costs, the availability of existing state-owned property suitable for the intended use, and specified locational criteria. The bill would require the department to give consideration to sites within existing mixed-use or commercial districts that have the greatest number of certain specified characteristics.	Vetoed.
