SUBJECT: Approval of Parcel Map Agreement (P-8746)

BACKGROUND INFORMATION

On October 16, 1979, the Council adopted Resolution No. 79-727 which approved a tentative parcel map for The West one-half of the southwest one-quarter of the northeast one-quarter of the northwest one-quarter of Section 18, Rancho Del Paso, owned by Bernard W. Campbell. A condition of approval of this tentative map was that Mr. Campbell enter into an agreement with the City to participate in and assist in the formation of any proposed assessment district which might be formed to construct improvements involving his property. This agreement is being presented for approval at this Council meeting.


