SUBJECT: One-Way Street Conversion - S, T and 3rd Streets

SUMMARY

On July 8th, the Council approved converting S, T and 3rd Streets from one-way to two-way. The necessary revised Resolution is attached to this letter for adoption.

BACKGROUND INFORMATION

One-way streets are established by Resolution and it will be necessary to adopt the attached changes before converting the one-way streets. Our present plans are to convert S Street from 3rd to 4th Streets, T Street from 3rd to 5th Streets and 3rd Street from S to W on July 24th. S Street between 4th and 5th Streets will be converted when the signal at 5th and S Streets has been modified a few months from now. The one-way street Resolution will need to be revised again at that time. Work is currently under way to complete the first phase of this conversion.

FINANCIAL DATA

There is \$150,000 in the 1979-80 Capital Improvement Program for implementation of the Central City Plan. These funds are identified by Cost Center 2433. The cost of converting S, T and 3rd Streets will be charged to this Cost Center.

RECOMMENDATION

It is recommended that the attached Resolution be adopted.

## A RESOLUTION DESIGNATING ONE-WAY STREETS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

### Section 1.

Pursuant to Section 25.63 of the Sacramento City Code when signs are erected giving notice thereof, traffic shall move only in the direction indicated on the posted signs upon the following streets:

The alley between C Street and D Street from 15th Street to 16th Street.

The alley between Capitol Avenue and N Street from 27th Street to 28th Street.

The alley between D Street and E Street from 13th Street to 14th Street.

The alley between H Street and I Street from 7th Street to 17th Street.

The alley between I Street and J Street from 5th Street to 17th Street.

The alley between J Street and K Street from 8th Street to 17th Street.

The alley between J Street and K Street from 21st Street to 22nd Street.

The alley between K Street and L Street from 6th Street to 17th Street.

The alley between L Street and Capitol Avenue from 7th Street to 19th Street and from 28th Street to 29th Street.

Beaumont Street between El Camino Avenue and Darina Avenue.

E Street between 7th Street and Alhambra Boulevard.

F Street between 7th Street and Alhambra Boulevard.

Freeport Boulevard between Broadway and 4th Avenue.

G Street between 7th Street and Alhambra Boulevard.

H Street between 6th Street and Alhambra Boulevard.

Holden Way between Del Paso Boulevard and Fairfield Street.

I Street between 3rd Street and 29th Street.

J Street between 3rd Street and Alhambra Boulevard.

L Street between Capitol Mall and Alhambra Boulevard.

Merchant Street between 7th Street and 8th Street.

N Street between 2nd Street and 28th Street.

Oakmont Street between Del Paso Boulevard and Dixie Avenue.

P Street between 2nd Street and Alhambra Boulevard.
