SUBJECT: APPROVAL OF PLANS AND SPECIFICATIONS, FUND TRANSFER OF \$142,736, ACCEPTANCE OF BID AND CONTRACT AWARD FOR H STREET RECONSTRUCTION PROJECT (38TH STREET TO 42ND STREET) (PN:TM41)

LOCATION AND COUNCIL DISTRICT:

H Street between 38th Street and 42nd Street. Council District 3.

RECOMMENDATION:

This report recommends that the City Council:

- Approve the plans and specifications;
- Adopt the resolution approving a fund appropriation in the amount of \$142,736 for the H Street Reconstruction (38th Street to 42nd Street) (PN:TM41);
- Accept the bid of **American Engineering and Asphalt** in the amount of \$634,648.25; and
- Authorize the City Manager to execute a contract for the H Street Reconstruction Project (38th Street to 42nd Street) (PN:TM41).

SUMMARY:

This project will reconstruct H Street between 38th Street and 42nd Street. Improvements include reconstruction of existing asphalt concrete, curb and gutter, installation of drain inlets and leads, and water line replacement. Sidewalk will not be reconstructed except where handicap ramps are required. The purpose of the project is to replace old and deteriorated pavement, improve drainage and improve the overall aesthetics in the area.

Additional funds are required to construct improvements for the City's Utilities Department.

COMMITTEE/COMMISSION ACTION:

None.

BACKGROUND INFORMATION:

- This project was advertised and bids were received on February 4, 1998, and are summarized below:

- The construction estimate was \$624,000.
- American Engineering & Asphalt did not meet the MBE goal of 10.57% nor the WBE goals of 9.5%, but did perform the good faith effort.
- Approval of the plans and specifications and award to American Engineering & Asphalt is recommended.

FINANCIAL CONSIDERATIONS:

- The current project budget for H Street Reconstruction (38th St. to 42nd Street) is \$735,000.00.
- The unobligated balance as of April 7, 1998 is \$641,920.
- Additional funding appropriations in the amount of \$142,736 from the Utilities Department will be made to the project.

A notice of categorical exemption will be filed for this project after approval of plans and specifications.

The action requested herein is consistent with Sacramento City Code, Title 58.

MBE/WBE EFFORTS:


To encourage minority participation, plans and specifications were sent to 10 plan rooms and construction services organization for publication. Four are directly involved with MBE/WBE construction firms. Staff actively recruited available MBE/WBE firms to participate in the bid process. The project was also announced on the Project Information Line and on the City's Internet site at www.sacto.org/bids. Project notices were sent to 30 organizations involved in MBE/WBE recruitment.

American Engineering and Asphalt did not meet the M/WBE goals, however, they performed a good faith effort.
