**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF  
ADULT PERFORMER PERMIT APPLICATION FEES**

**WHEREAS**, Sacramento City Code section 5.06.070(A) authorizes the establishment of a non-refundable adult performer permit application fee.

**WHEREAS**, Sacramento City Code section 5.06.140(B) authorizes the establishment of a non-refundable adult performer permit renewal application fee.

**WHEREAS**, the City Council's proposed action in setting the application and renewal fees is for the purpose of meeting operating expenses, including those expenses reasonably related to the processing of adult performer permit applications, and, as such, said action is exempted from environmental review pursuant to Public Resources Code Section 21080(b)(8).

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO THAT:**

1. The City of Sacramento has determined the adult performer application fee to be established as \$109.00.

**MERGED DOWNTOWN SACRAMENTO REDEVELOPMENT PROJECT AREA:  
AUTHORIZATION TO EXCLUSIVELY NEGOTIATE WITH HARVEGO REAL ESTATE, LLC  
FOR THE DEVELOPMENT OF THE ORLEANS HOTEL SITE IN OLD SACRAMENTO**

**WHEREAS**, the Amended Redevelopment Plan for the Merged Downtown Sacramento Redevelopment Project Area was prepared by the Redevelopment Agency of the City of Sacramento ("Agency") and approved and adopted on June 17, 1986, by Ordinance No. 86-063, -064, 065, 0-66, and -067 of the City Council of the City of Sacramento and subsequently amended:

**WHEREAS**, two of the goals of the Redevelopment Plan for the Project Area are:

1. To retain and improve existing businesses, as appropriate, within commercial areas of the Merged Project Area; and
2. To improve the visual and aesthetic appearance of the Merged Project Area.

**WHEREAS**, the Agency adopted the Merged Downtown Five Year Strategic Plan and Implementation Plan for the Project Area on February 29, 2000;

**WHEREAS**, the Downtown Five Year Strategy and Implementation Plan identified the development of opportunity sites in Old Sacramento:

**WHEREAS**, the Orleans Hotel Site in Old Sacramento is properly zoned and situated for commercial use;

**BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF THE CITY OF SACRAMENTO;**

Section 1: The above statements are true and correct.

Section 2: The City Manager is authorized to exclusively negotiate, on behalf of the Agency, with Harvego Real Estate, LLC for the development of the Orleans Hotel site in Old Sacramento. Staff is directed to follow the adopted *Guidelines for Individual Project Review*.
