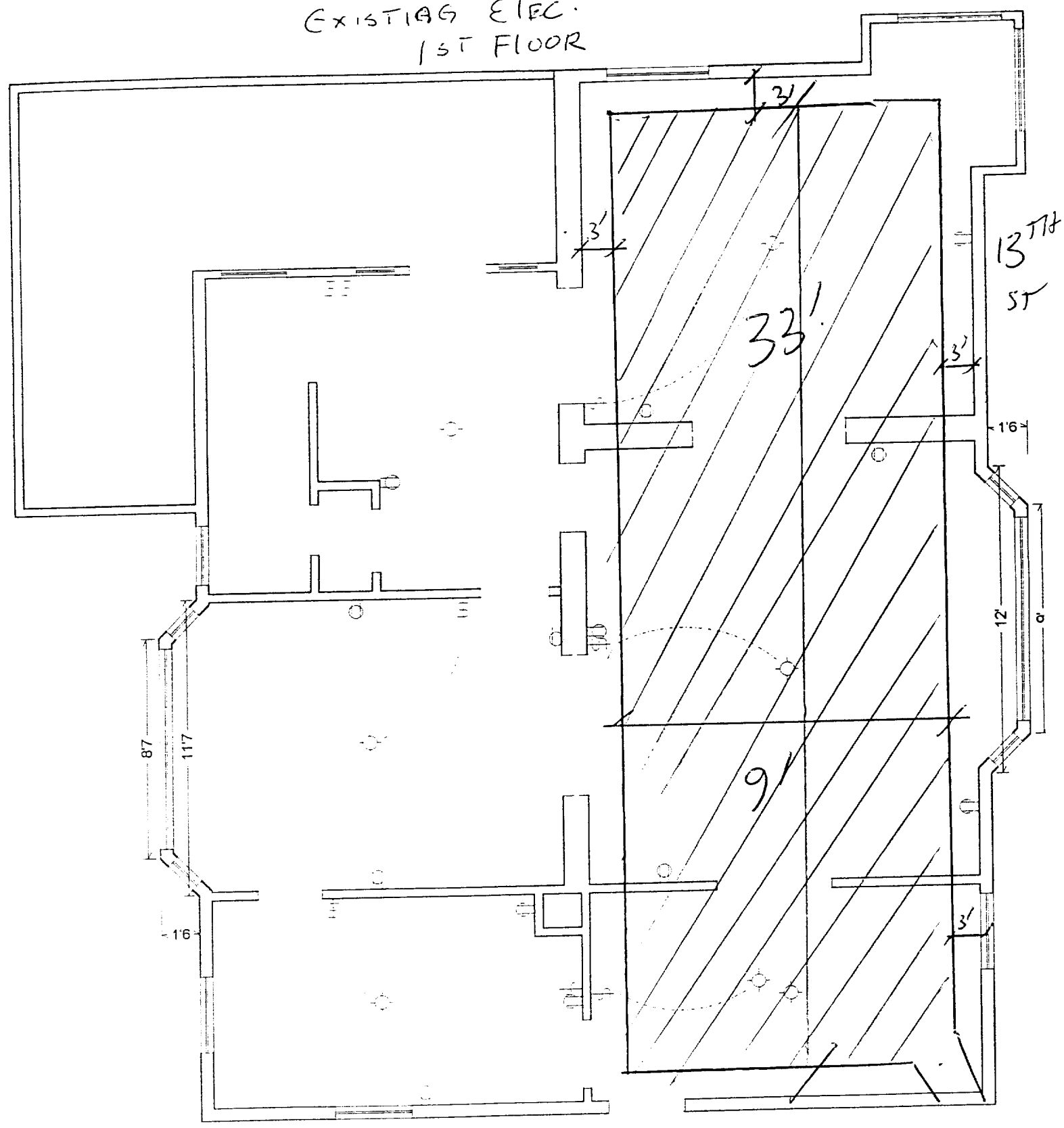

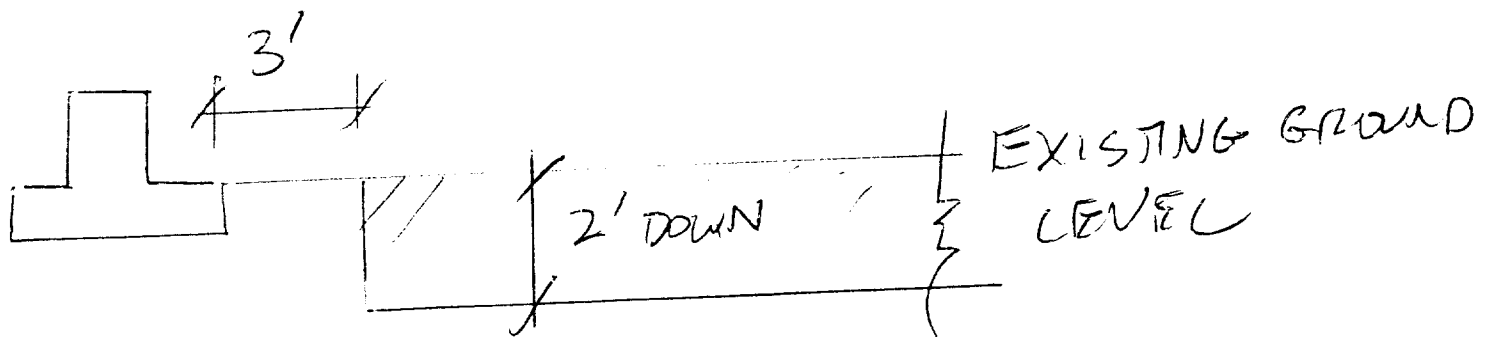
EXISTING ELEC.
