STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Roofing shall be 25-year laminated dimensional composition shingle.
2. Repair any damaged stucco to match existing.
3. Provide new outriggers at eave.
4. Repair south soffit to match existing north soffit.
5. No roof-mounted mechanical equipment is allowed.
6. Repair/replace existing damaged ogee gutters as necessary.
7. Replace existing siding as necessary at dormers to match existing.
8. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
