SUBJECT: American River Parkway Plan (M84-024)

### SUMMARY

The City Planning Commission and County Policy Planning Commission have held a total of five public meetings to update the 1975 American River Parkway Plan. The County Board of Supervisors approved the updated plan for the County's portion of the parkway on December 11, 1985. The City's plan would include the updated plan and an implementation program from the existing 1975 plan to ensure that private lands within the City's portion of the parkway are regulated pursuant to the City's Zoning Ordinance. The County's plan plus the City's 1975 Implementation Program constitutes the recommended City's 1985 American River Parkway Plan. The City Planning Commission unanimously approved the staff recommendation that the City Council ratify the County's Negative Declaration and adopt the attached resolution approving the 1985 American River Parkway Plan.

### BACKGROUND

A specific plan for the City portion of the American River Parkway was approved by the City Planning Commission on August 26, 1975 and adopted by City Council on September 25, 1975. Approximately 10 years have elapsed since the City and County have adopted their respective plans. The preparation to update this Parkway Plan was started in February 1984. An update committee composed of representatives from various interest groups concerned with the Parkway, including an ex-officio staff person from City Planning, was appointed by the Board of Supervisors. The Plan was developed over a period of approximately 2 years. The Committee's main objective was to resolve issues which have occurred since the adoption of the 1975 plan.

The plan consists of goals and policies, specific area plans, and an implementation section. The staff considers the proposed plan to be generally consistent with the City's adopted 1974 General Plan and 1975 American River Parkway Plan.

A separate action plan will be prepared in approximately 1 year by the County Parks and Recreation Department after City and County adoption of the updated plan. The County's action plan will regulate parkway lands other than those regulated by the City's Zoning Ordinance. The action plan will be detail specific to implement the goals and policies of the updated plan and will be distributed to the City for review and comment prior to its approval by the County.

The updated plan will be reviewed approximately every 5 years, or sooner if necessary, to reflect changing conditions. The action plan will be reviewed on a yearly basis by the County Recreation and Parks Commission.

At its November 7, 1985 meeting, the City Planning Commission ratified the County's Negative Declaration and approved the updated plan in concept. The Sacramento County Board of Supervisors adopted this plan on December 11, 1985. At its February 6, 1986 meeting, the City Planning Commission approved the staff's recommendation that the City Council adopt the updated plan.



The County's plan plus the City's 1975 Implementation Program constitutes the City's 1985 American River Parkway Plan.


RECOMMENDATION

## RESOLUTION ADOPTING THE 1985 AMERICAN RIVER PARKWAY PLAN (M84-027)

WHEREAS, the City Council has held a Noticed Public Hearing on the document entitled "The American River Parkway Plan"; and

WHEREAS, the updated Parkway Plan has been adopted by the Board of Supervisors of Sacramento County; and

WHEREAS, the Sacramento City Planning Commission has recommended the adoption of the updated Parkway Plan.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Sacramento:

1. That Resolution No. 75-477 adopted by the Council of the City of Sacramento on September 25, 1975 be rescinded.
2. That the Implementation Program (Part II) of the City's 1975 Parkway Plan be retained as an appendix to the 1985 Parkway Plan.
3. That the use of privately-owned property within the City portion of the American River floodplain shall continue to be regulated by the City Zoning Ordinance (Ordinance No. 2550, Fourth Series, as amended).
4. That the 1985 American River Parkway Plan is hereby adopted as a specific plan of the Sacramento City General Plan.
