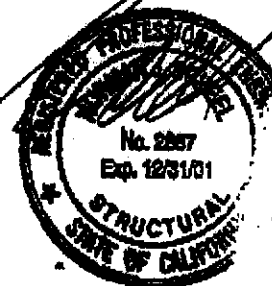

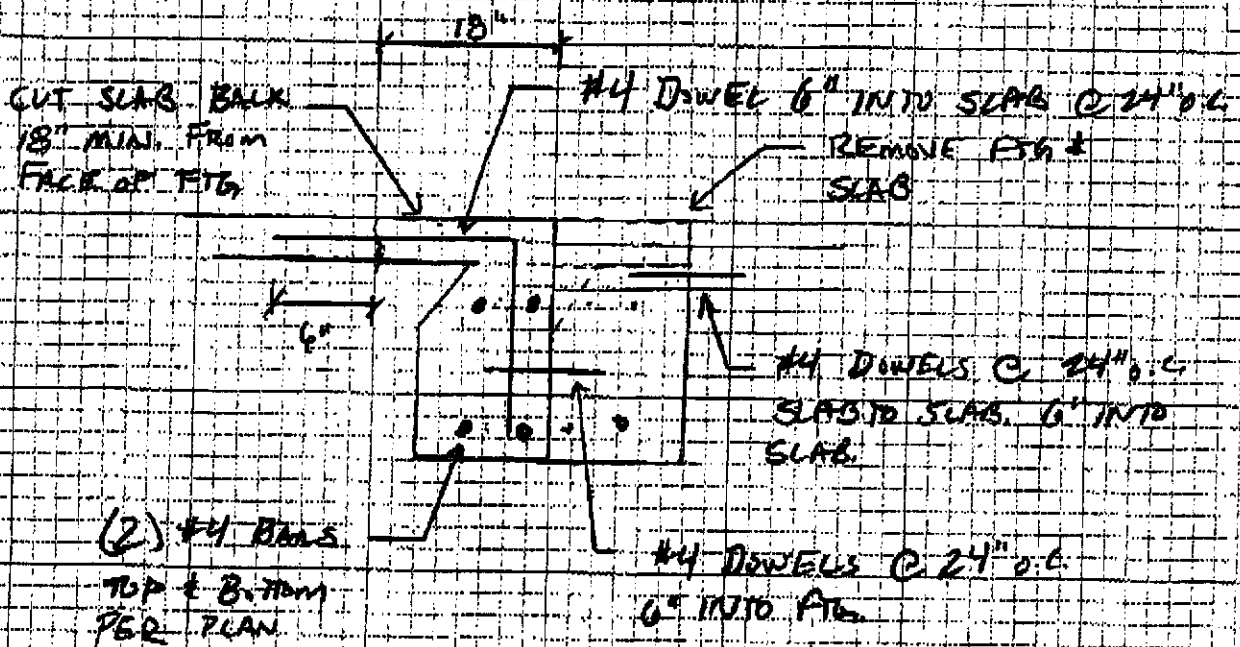

LOT 271 - PLAN 2341 - FTG REPAIR @ GARAGE

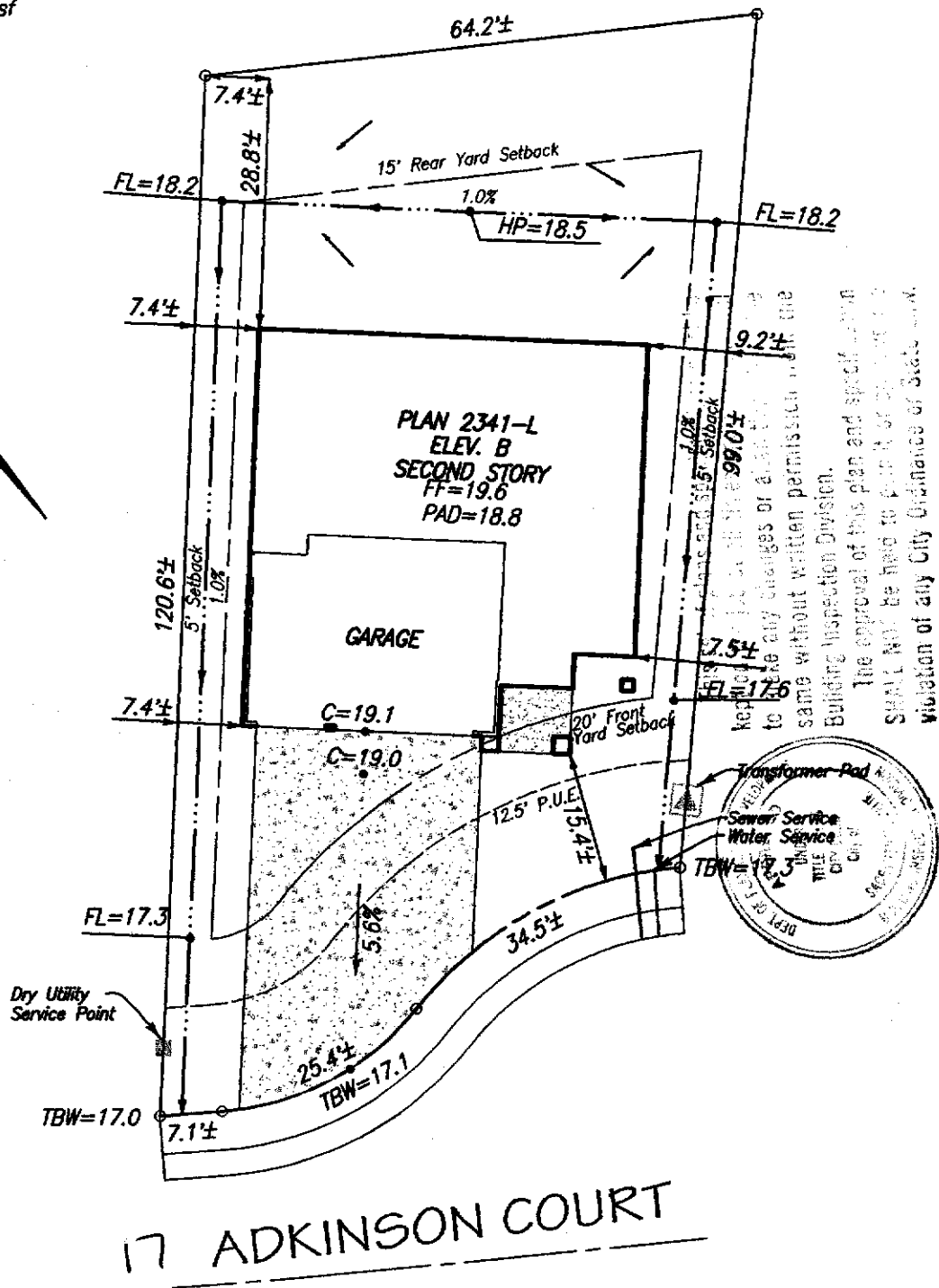

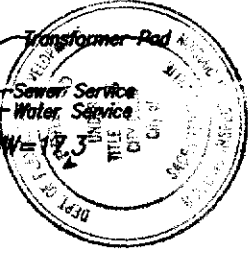
