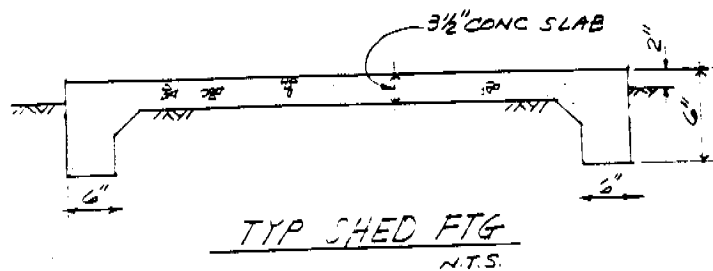

# REQUIREMENTS FOR SHED FOUNDATIONS

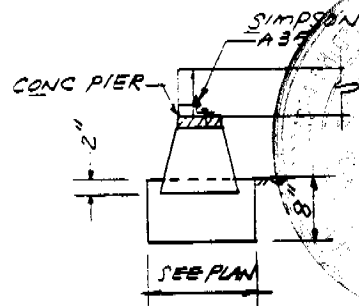
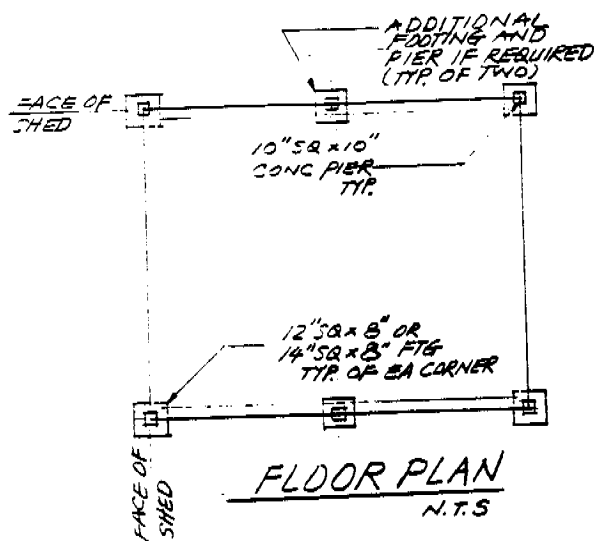
A. For sheds 64 sq. ft. to 119 sq. ft.:

1. 3 1/2" concrete slab with 6" x 6" perimeter footing.



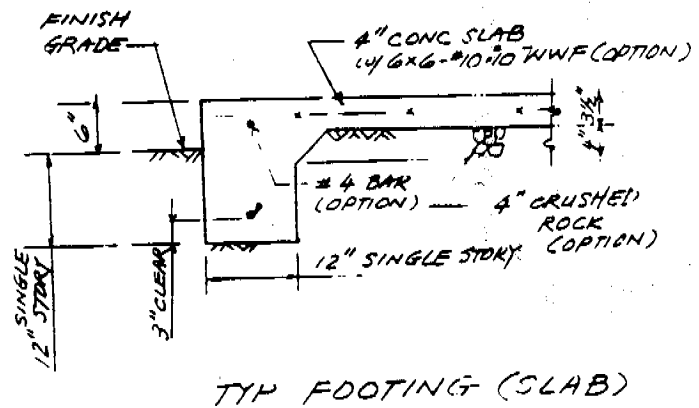
or

2. 10" x 10" x 10" Concrete piers with corner piers set on 12" x 12" x 8" footings.



B. For sheds 120 sq. ft. and larger:

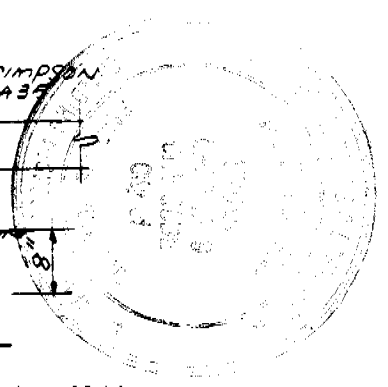
1. 4" concrete slab with standard perimeter footing.



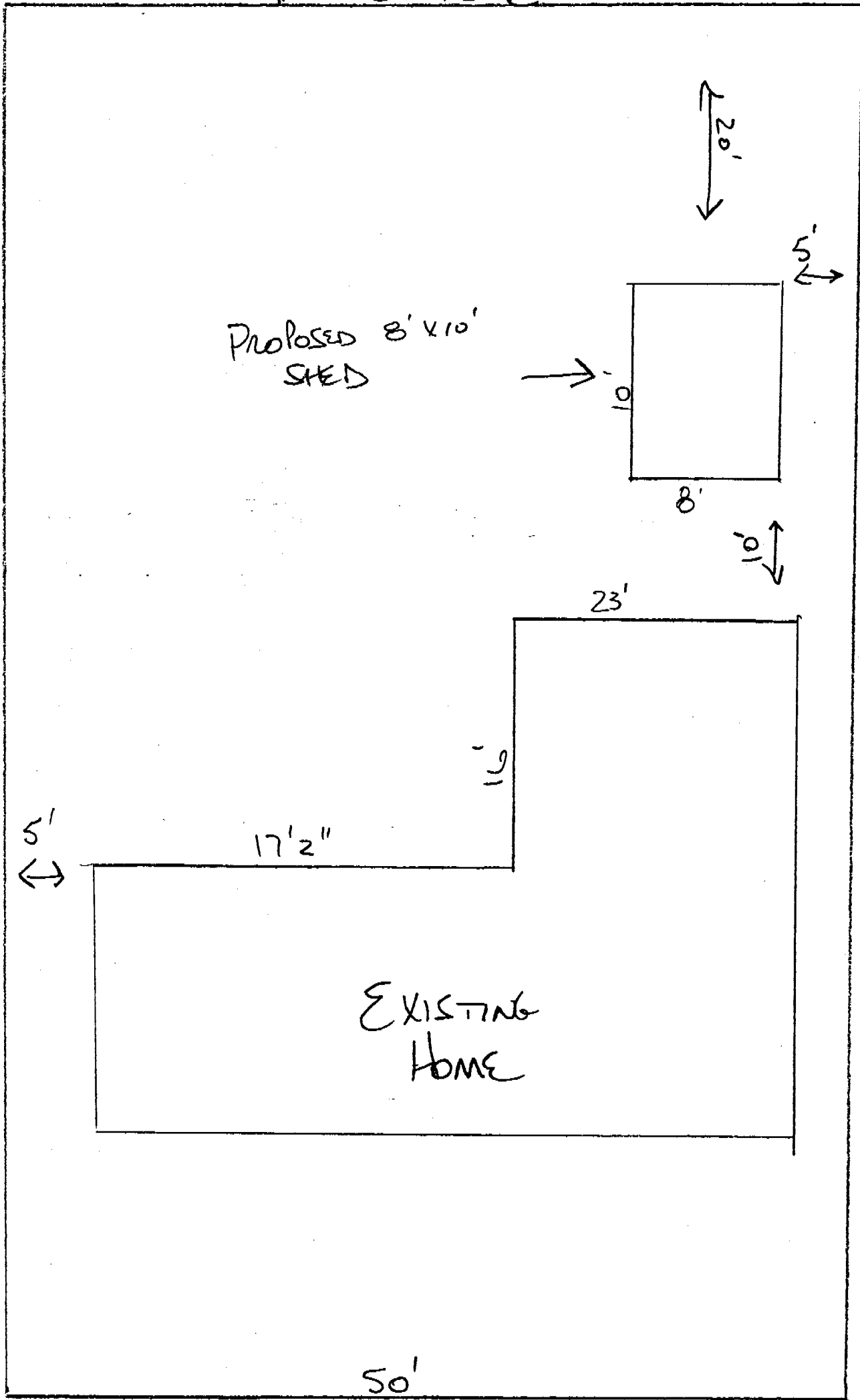

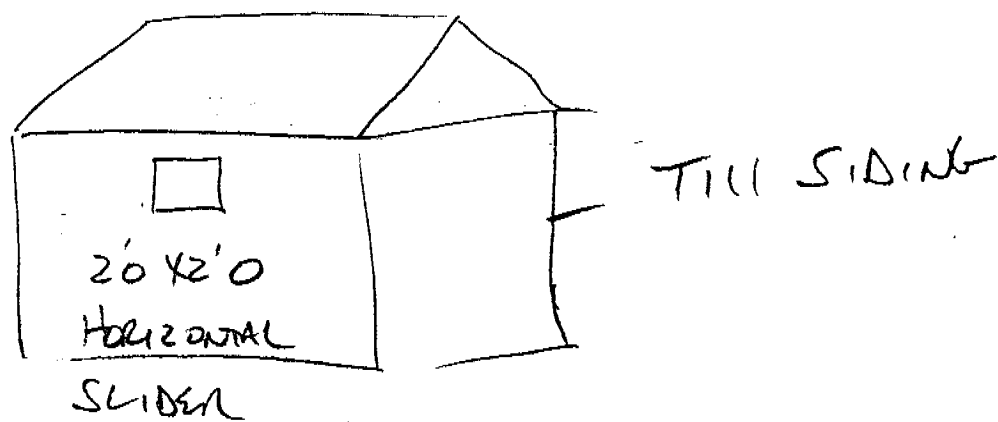
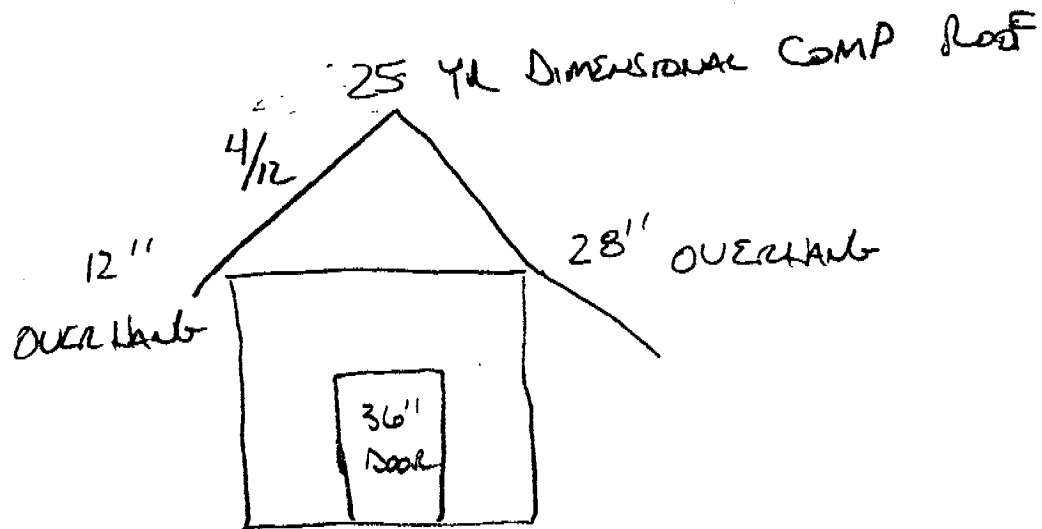
KANDOUSE HOME
