Description/Analysis

Issue: This report provides information to the City Council about emergency contracts issued by the Department of General Services under City Manager authority as required by Sacramento City Code Chapter 3.60.070. This report includes emergency contracts issued from April 1, 2009 through June 30, 2009. One emergency contract was issued during this period. Specific information on this contract is included in Attachment 2.

Policy Considerations: This action is consistent with Sacramento City Code Chapter 3.60.070, and the City Auditor's recommendation contained in the internal audit report on the bidding and contract process examination of the Department of General Services dated April 25, 2006 to notify City Council of any emergency contracts.

Commission/Committee Action: Not applicable

Environmental Considerations:

California Environmental Quality Act (CEQA): The Environmental Services Manager has determined that the report back regarding emergency contracts is exempt from the requirements of the California Environmental Quality Act (CEQA), pursuant to Section 15061(b)(3) of the CEQA guidelines. Exemption 15061(b)(3) consists of an activity covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA.


Sustainability Considerations: Not applicable

Rationale for Recommendation: The Public Safety Administration Building (PSAB) has been monitored for water leaks ever since a major waterproofing project was completed around the basement walls approximately five years ago. Recent inclement weather and high water caused new small leaks that were unrelated to past repairs. Because of the nature of the work, health safety concerns (mold) and the potential for further existing water proofing membrane, staff had to act quickly to have a specialized contractor make the necessary repairs.

Ashron Construction was contracted to do the waterproofing repairs for the PSAB.

Financial Considerations: Funding for emergency contracts is provided from department operating budgets or capital improvement projects (CIP). The emergency contract issued from April 1, 2009 through June 30, 2009, was funded by the City Facility Deferred Maintenance (B13000500) fund.

Emerging Small Business Development (ESBD): The emergency contract identified in this report was not issued to an ESBD certified company.

BACKGROUND INFORMATION

On April 25, 2006, the City Auditor recommended in the internal audit report on the bidding and contract process examination of the Department of General Services that the department report emergency contracts to City Council, as required by Sacramento City Code Chapter 3.60. It is the intention of the Department to comply with that recommendation by reporting to City Council on emergency contracts issued under City Manager authority as soon as possible after the end of each quarter of the fiscal year.

According to City Code 3.60.070, the City Manager is authorized to negotiate and contract for public projects without advertising for bids when public interest and necessity demand immediate action, repair or replacement to safeguard life, health, or property, to permit the continued conduct of city operations or services, or to mitigate further damage.

This report covers emergency contracts let by the Department of General Services under City Manager authority from April 1, 2009 through June 30, 2009. Specific information about the emergency contract is included in Attachment 2.
