A brief was submitted by Kenneth Wright, Executive Secretary of the Sacramento City Employees Association on behalf of Mr. Wirts outlining the reasons why, in his opinion, Mr. Wirts' position is improperly classified.


The job survey of Mr. Wirts' position which was prepared by the Personnel Department staff was explained briefly by the Personnel Officer and by Earl Wilson, Personnel Technician, who conducted the job survey and which outlined the reasons for denial of the reallocation request. Also present at the hearing were Charles Inderbitzen, Automotive Maintenance Superintendent; Bill Robbins, Purchasing Agent; J. Lyle Lack, former Storekeeper, and Elmer Wirts.

The brief prepared on behalf of Mr. Wirts were explained in detail by Mr. Wright. Mr. Wirts explained the details of his job and was questioned at length by the various board members. Mr. Inderbitzen and Mr. Robbins also explained the duties performed by Mr. Wirts and were also questioned by the Board members.

Request was made by the Personnel Officer that any decision on this appeal should be postponed until such time as the brief submitted by Mr. Wright could be analyzed and a report prepared for the Board.

Mr. Grebitus, Chairman of the Board, advised that the appeal would be studied and given further consideration at the next regular meeting to be held October 4, 1961.

There being no further business, the meeting adjourned at 4:00 P.M. to meet again at the call of the Chair.
