SUBJECT: Metropolitan Arts Division - Request for Increase in Appropriations - California Arts Council Grant

SUMMARY:

This report recommends a \$12,000 increase in appropriations to the FY 1981-82 budget of the Metropolitan Arts Division to reflect the receipt of a grant under the State/Local Partnership Program from the California Arts Council.

BACKGROUND INFORMATION:

On October 6, 1981, the Sacramento Metropolitan Arts Commission received a contract from the State of California (California Arts Council) to participate in the 1981-82 State/Local Partnership Program.

The program, now in its second year, is in joint participation with the County of Sacramento and its designated arts agency (SMAC).

Under the 1981-82 guidelines, the program objectives are (1) to complete the analysis of data gathered in the arts planning process initiated under the 1980-81 program and (2) establish a grant review mechanism with a methodology for allocation of future additional California Arts Council program funds.

FINANCIAL DATA:


The State/Local Partnership Program makes available \$12,000 in non-matching funds to accomplish the program objectives, and, no additional City or County funds are required. The appropriation increase will be supported by revenue forthcoming from the California Arts Council.

**RESOLUTION AMENDING THE CITY BUDGET FOR FY 1981-82
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(METROPOLITAN ARTS DIVISION) STATE/LOCAL
PARTNERSHIP PROGRAM GRANT**

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of a grant from the California Arts Council to participate in the 1981-82 State/Local Partnership Program requires an appropriation for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
 - a. By adding thereto the sum of \$12,000 to budget number 1-01-2281-7243-4258 relating to the expenditure of funds for the California Arts Council's State/Local Partnership Program.
 - b. The above appropriation increase is supported by revenue forthcoming from the California Arts Council.
