

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

June 25, 1937

The Civil Service Board met in special session in the office of the Board at 8:00 o'clock P.M.

PRESENT: Commissioners Deise, Stacy, and President Chenu.  
ABSENT : None

The minutes of April 1, 8, 15, 20, 21, 24, 29, May 13, 15, 20, 21, and 27, 1937 were approved as read.

ELECTRIC PUMP OPERATOR EXAM.

Mr. Carl Hoskinson, Chief Engineer for the Water Dept., was present discussing duties of various employees at the

Filter Plant performing duties of Operator, Oiler, and Stationary Fireman. Mr. Hoskinson expressed the opinion that better efficiency could be secured if it were possible for his department to use employees intermittently for these positions. After discussion it was the opinion of the Board than an examination could be given covering these subjects into one classification and appointments made from the result of the list. The Board requested Mr. Hoskinson to present a list of employees in the Engineering Dept. who might be eligible to take a promotional examination for this position (Pump Operator).


