SUBJECT: PARTNERSHIP WITH THE ELK GROVE UNIFIED SCHOOL DISTRICT

LOCATION AND COUNCIL DISTRICT: Valley High School, District 8

RECOMMENDATION:

- Authorize the City Manager to execute a Memo of Understanding (MOU) with Elk Grove Unified School District (EGUSD) to implement a one-year School Resource Officer (SRO) program.
- Augment the Police Department's operating budget by \$83,020.
- Augment the Police Department's revenue budget by \$83,020.

SUMMARY:

The Police Department is requesting City Council authority to implement a School Resource Officer (SRO) program by approving the negotiated police services contract with the EGUSD. The program period is for one year, commencing January 1, 2000 through December 31, 2000. EGUSD will pay for the full program cost as well as provide a patrol vehicle. The Police Department is requesting an augmentation of \$83,020 to the Department's operating budget. Funding received from EGUSD will fully offset the SRO labor costs to the Police Department.

COMMITTEE/COMMISSION ACTION:

BACKGROUND:

The Police Department and EGUSD have negotiated an agreement to fund 1.0 FTE police officer for general school and community safety. EGUSD will pay for the labor and safety equipment costs, including all the salary and benefit costs. The EGUSD will also purchase and maintain the vehicle used by the Sacramento police officer. In accordance with the City Council resolution addressing basic principles of school safety, the SRO will develop and support school security activities and crime prevention programs.

FINANCIAL CONSIDERATIONS:

Funding from EGUSD will pay for the salary and benefit costs of the officer. EGUSD will purchase and maintain the police vehicle. The total labor cost to EGUSD for the one-year program is \$83,020, including safety equipment. This EGUSD partnership is revenue neutral to the City.

POLICY CONSIDERATIONS:

Implementation of an SRO in EGUSD is consistent with previously adopted policy directed at citywide school safety and furthers the principles of the community oriented policing philosophy.

ENVIRONMENTAL CONSIDERATIONS:

This proposal does not constitute a "project" and is therefore exempt from the California Environmental Quality Act according to CEQA guidelines Section 15061 (b)(1) and 15378(b)(3).
