SUBJECT: Realignment of Arcade Creek at Haggin Oaks Golf Course (PN:0A41) -
Contract Award

SUMMARY

This project has been advertised for bids. Bids have been received and contract award is recommended.

BACKGROUND

This project will realign the channel of Arcade Creek where it crosses the fairway of the thirteenth hole of the Haggin Oaks eighteen hole golf course. The realignment of the channel will minimize interference with play on that fairway, resulting in a decrease in playing time and eliminating a bottleneck on the golf course.

On July 21, 1987 the City Council approved the plans and specifications for this project. Bids were received and opened by the City Clerk on August 11, 1987. The bids received were:


RECOMMENDATION

It is recommended that the City Council accept the low bid of C. Perini Construction Co. in the amount of \$97,330 and award the contract.


