SUBJECT: Latchkey Program - Authorization to Submit Local Agreement No. CD-1303  
to the California State Department of Education

SUMMARY

This report recommends that City Council authorize, by resolution, submittal of Local Agreement No. CD-1303 to the California State Department of Education on behalf of the Recreation Division for the Latchkey program.

BACKGROUND INFORMATION

On January 21, 1986, the City Council authorized the City Manager to submit a grant proposal to the California State Department of Education - Child Development Division on behalf of the Recreation Division of the Department of Parks and Community Services. The proposal was to provide funding for a "Latchkey" program for children. The grant was awarded in the amount of \$36,911 for one month of the 1985-86 fiscal year and \$131,298 for FY 1986-87.

The proposed agreement for FY 1987-88 provides for the continuation of the Latchkey program at the same maximum reimbursable amount of \$131,298, the same amount as FY 1986-87 funding. The subsidized rate per participant, however, will be increased from \$1.4847 to \$2.0862 for Fiscal Year 1987-88. The increased level of subsidy per child will provide for additional services to each subsidized child.

FINANCIAL DATA

No additional City funds are required to continue this Latchkey program. All direct costs associated with the program are either reimbursed from the grant or obtained from parent participant fees. The total cost of the program and revenue sources have been included in the proposed FY 1987-88 budget.

RECOMMENDATION


