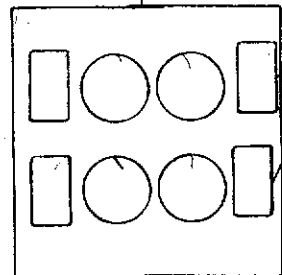

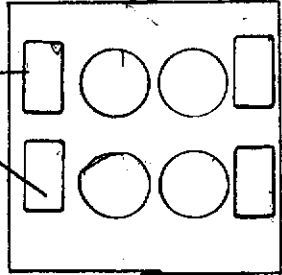

40 AMP 2 Pole Main Breakers

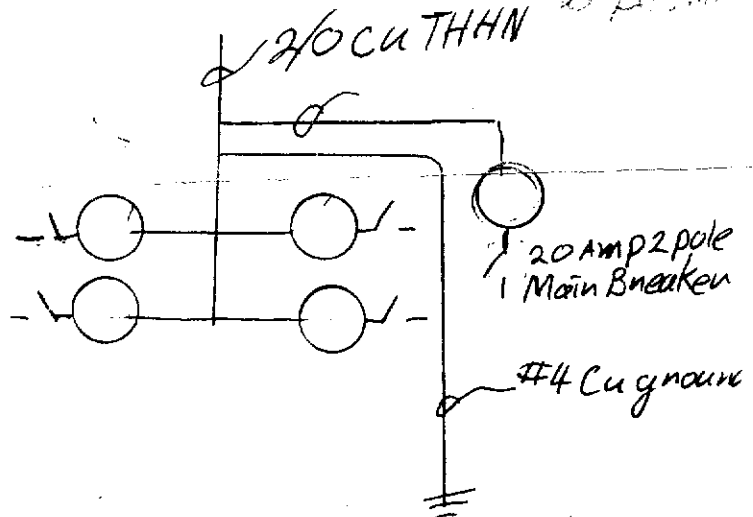
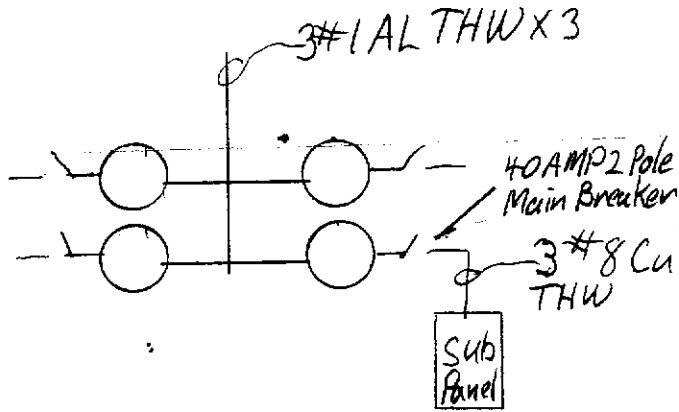
