

MINUTES OF CIVIL SERVICE BOARD  
CITY OF SACRAMENTO  
SPECIAL MEETING

June 7, 1952

The Civil Service Board met in special session at 9:30 A.M. at the Sacramento High School.

PRESENT: Commissioners Deise and Wright  
ABSENT : Commissioner Marty

Minutes of the previous meeting were approved as read.

PATROLMAN EX. #311

The written portion of Patrolman Examination No. 311 was held on this date at 7:30 A.M. in the Sacramento High School.

After reviewing the outcome of raw scores for the written portion of said examination, it was the order of the Board that those candidates receiving a raw score of at least 90, be considered as receiving a passing grade of 70%.

Identification envelopes were thereupon opened and those candidates receiving a passing grade in the written portion of said examination competed in the mile run endurance test.

Upon the completion of the mile run endurance test, the Board adjourned to meet at 1:30 P.M. at the Sacramento Turn Verein, 33rd & J Streets to complete the foregoing examination.

The Board reconvened at 1:30 P.M. at the Sacramento Turn Verein for the purpose of conducting the athletic physical tests and oral interviews for Patrolman Examination No. 311.

OPINION OF CITY ATTORNEY

Re: Veteran's Preference

In accordance with an opinion filed by the City Attorney, Mr. Deise moved that the Civil Service Rules and Regulations concerning Veteran's preference be amended as follows; seconded by Mr. Wright and motion carried.

SECTION 10a - A new section amending Section 10, Article VI of the Civil Service Rules and Regulations concerning Veterans Preference.

For the purpose of this section "Veteran" shall apply to any person who has served full time in the Army, Navy, Marine Corps or Revenue Marine Service during the period September 16, 1940 to December 31, 1946, inclusive, or from June 27, 1950 to a future date to be established by proclamation of the Governor of the State of California, and received an honorable discharge therefrom, or was discharged under other conditions as specified in Section 10 of the Civil Service Rules and Regulations.

Communication from A. C. Jerabek appealing the Board's action in rejecting his application for Uniform Fireman Examination No. 305 was considered.

Communications from Fire Chief Terence Mulligan, Assistant City Engineer Carl Jennings and Water and Sewer Foreman Norman Squires with reference to applicant's previous employment with the city, were read and ordered filed.

After general discussion by members of the Board, Mr. Wright moved that the foregoing appeal be denied; seconded by Mr. Deise and motion carried.
