**SUBJECT: BURNETT/LARKIN WATER MAIN REPLACEMENT AND STREET RECONSTRUCTION PROJECT (PN:ZH11): TRANSFER FUNDS IN THE AMOUNT OF \$361,020 AND AWARD CONTRACT TO NAVAJO PIPELINES, INC., FOR AN AMOUNT NOT TO EXCEED \$435,325**

**LOCATION AND COUNCIL DISTRICT:**

The Burnett/Larkin Water Main Replacement & Street Reconstruction Project is located in Council District 4. See attached location map.

**RECOMMENDATION:**

Staff recommends that the City Council:

- approve a fund transfer in the amount of \$361,020 to the Burnett / Larkin Water Main Replacement & Street Reconstruction Project (PN:ZH11)
- accept the low bid from Navajo Pipelines, Inc., for an amount not to exceed \$435,325 and award the contract.

**SUMMARY**

Bids were received from eight (8) contractors and opened by the City Clerk on July 14, 1999. The low bidder was Navajo Pipelines, Inc., with a bid of \$435,325. Navajo Pipelines, Inc., met the Emerging and Small Business Enterprise (ESBE) goals. It is therefore proposed to award the contract to Navajo Pipelines, Inc., for \$435,325.

3. The City Manager and City Clerk are authorized to sign and execute a contract with Navajo Pipelines Inc., for the Burnett/Larkin Water Main Replacement and Street Reconstruction Project (PN:ZH11) for an amount not to exceed \$435,325.
