SUBJECT: Franklin Boulevard Widening - Union House Creek to Big Horn Boulevard  
(PN:TF26) - Amend Revenue Budget and Appropriate Funds

SUMMARY

Funds have been deposited to cover a portion of the costs of constructing the street improvements along Franklin Boulevard adjacent to the Southport Village subdivision. It is recommended that the funds deposited be appropriated to the project.

BACKGROUND

The subject project is part of the City's Measure A program and will be constructed in the Spring of 1991. The Southport Village subdivision has deposited funds to provide for construction of street frontage improvements required along Franklin Boulevard. These funds will be added to the project budget and the frontage improvements will be constructed as part of this project.

FINANCIAL DATA

The project budget currently includes \$579,000 in Transportation Sales Tax funds and \$1,150,000 in Capital Grants funds (from the County of Sacramento). Funds in the amount of \$28,819.00 were received and deposited in the Revenue Account #248-TF26-3599 on March 21, 1990. (See attached memorandum and receipt). These funds will be added to the project budget.

It is recommended the Budget and Finance Committee recommend approval of the attached resolution to the full City Council.



SUBJECT: CONSTRUCTION CONTRIBUTIONS FOR IMPROVEMENTS ON FRANKLIN  
BOULEVARD BY SOUTHPORT VILLAGE SUBDIVISION (P-86210;JN:2280)

Per the City Code, the developer of Southport Village Subdivision was required to contribute to the construction of Franklin Boulevard, south of Union House Creek. In compliance with the code, this office collected a total of \$33,908.89 for this contribution. Part of the contribution was the actual cost of the improvements and part was for Engineering Fees.

The actual construction cost of improvements the developer was responsible for totaled \$28,819.00. On March 21, 1990, this amount was deposited under organization No. TF26 (Fund 248, Agency 500), which we believe was appropriate for the Franklin Boulevard Project. Therefore, these funds should already be in the proper account for that project.

The remaining funds, \$5,089.89, were collected for the purpose of plancheck, inspection, street light design and materials testing. Per our standard procedure, these funds were deposited under our organization number, 3136. At the end of the last fiscal year, these funds were subsequently transferred to the General Fund.
