
Dear Building Inspector:

We thank you for your cooperation in this matter.

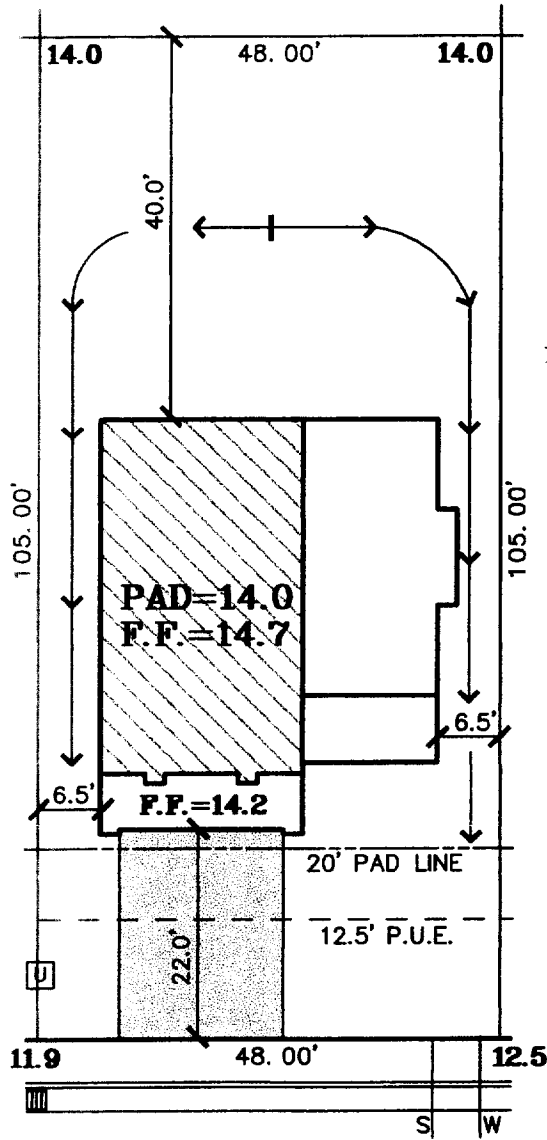

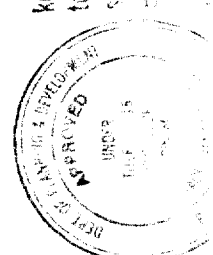
