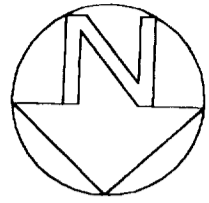

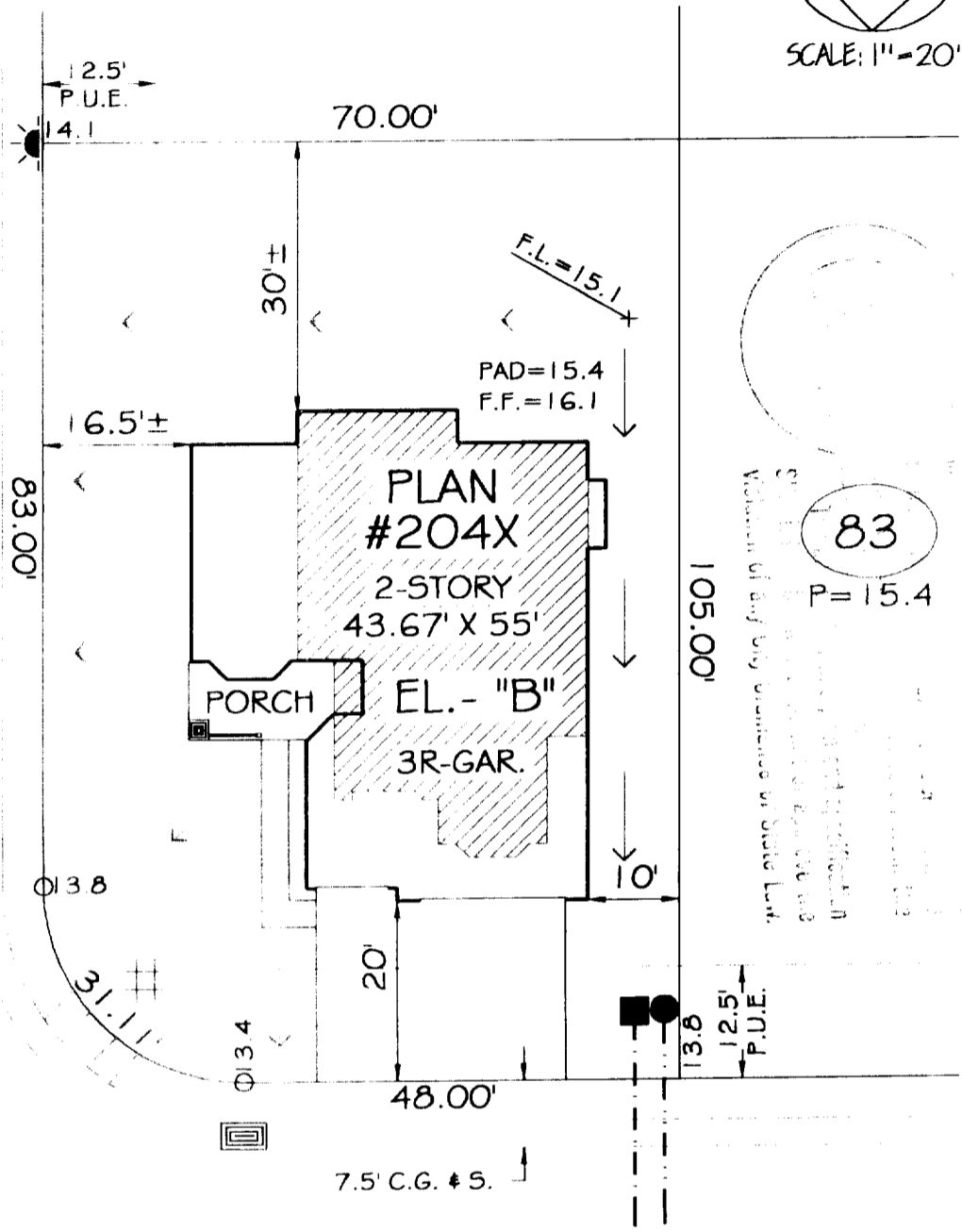
REMARKS
