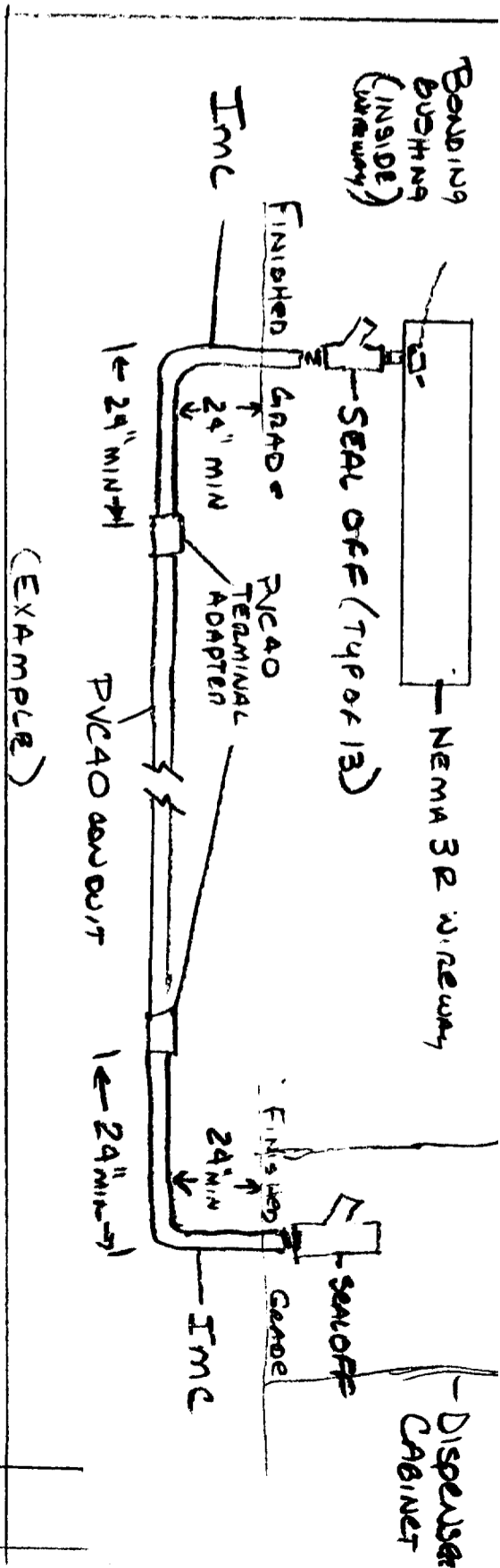

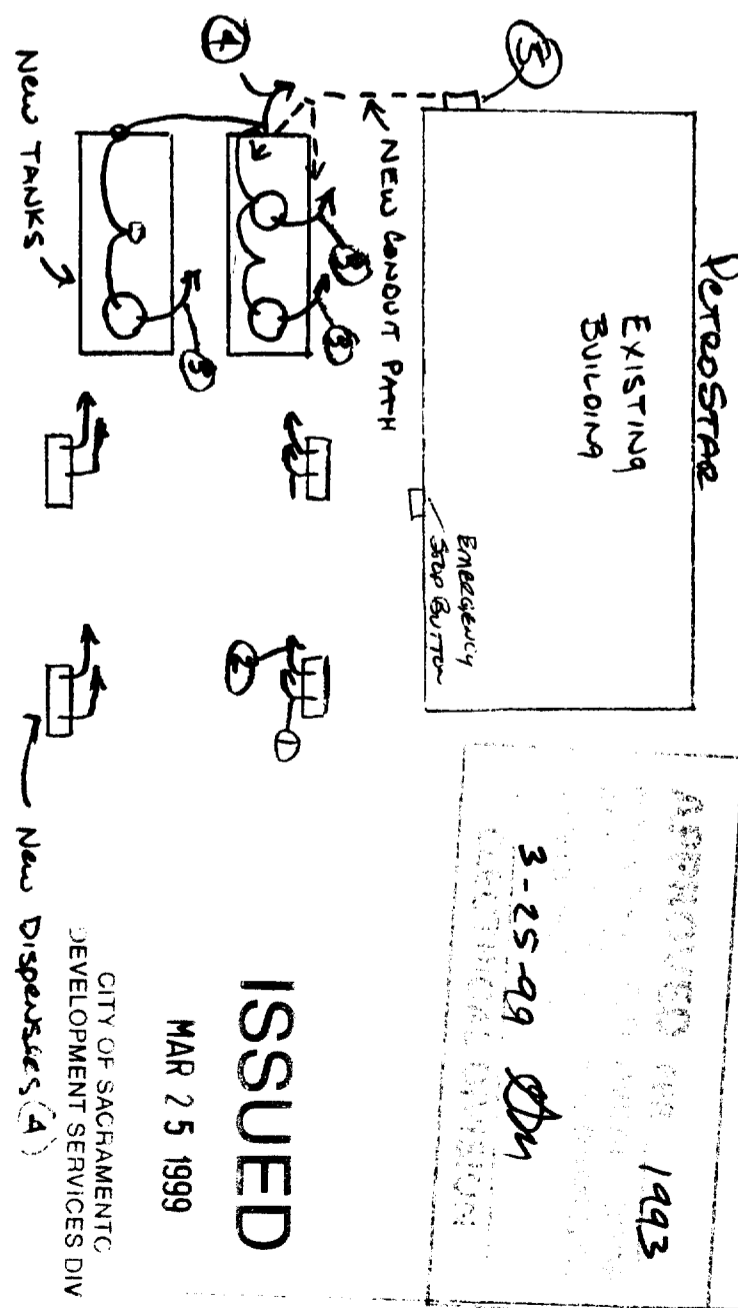
1. ALL CONDUITS ENTERING/EXITING CLASS 1 DIV 1 AREAS - SHALL HAVE A SEAL OFF FITTING INSTALLED AT EACH END.
2. ALL CONDUIT SHALL HAVE MINIMUM 24" COVER
3. GROUNDING BUSHINGS SHALL BE PROPERLY INSTALLED AND BONDED IN WIREWAY
4. CONDUIT RUNS SHALL BE IMC/OVC TO WITH IMC TO A MINIMUM OF 24" ABOVE THE RUN BEFORE TRANSITIONING TO OVC (SEE DETAIL ABOVE)
5. GASOLINE AND OIL RESISTANT THHN STRANDED WIRE TO BE USED.
