**SUBJECT:** APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID,  
AWARD CONTRACT, AND ESTABLISH CIP PROJECT FOR THE  
SACRAMENTO RIVER DOCKS UTILITIES PROJECT (KCXX)

**LOCATION and COUNCIL DISTRICT:**

Front Street, Capitol Avenue south to Neasham Circle, Sacramento: Council District 1.

**RECOMMENDATION:**

This report recommends that the City Council:

- Approve the plans and specifications;
- Accept the bid of Civil Engineering Construction in the amount of \$162,860;
- Authorize the City Manager to execute a contract for the Sacramento River Docks Utilities; and
- Approve the Resolution amending the 1996/1997 Capital Improvement Program by establishing Sacramento River Docks Utilities project based on the Individual Project Agreement with SHRA and the City of Sacramento. (KCXX).

**APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID, CONTRACT  
AWARD FOR THE SACRAMENTO RIVER DOCKS UTILITIES PROJECT (KCXX)**

December 4, 1996

**SUMMARY:**

This project is the second phase of improvements for the Sacramento River Docks area. The Docks project area opens up access from Old Sacramento to Miller Park on the south and Crocker Arts Gallery on the east.

This project includes the construction and installation of the utilities in Front Street to support the public courtesy boat dock, floating barge and public access ways now under construction and due for completion in May of 1997.

**COMMITTEE/COMMISSION ACTION:** None.

**BACKGROUND INFORMATION:**

- This project was authorized in the 1994/95 Sacramento Housing and Redevelopment Agency (SHRA) Capital Improvement Program.
- SHRA approved the Sacramento Master Plan on April 6, 1995 and a phased project program on August 7, 1996.
- On September 3, 1996 Council awarded a contract for the Sacramento River Docks Project A. The attached resolution amends the 1996/1997 Capital Improvement Program (CIP) by establishing Sacramento River Docks Utilities project based on the Individual Project Agreement (IPA) with SHRA and the City of Sacramento (KC11) for that project and this project (KC13).
- This project was advertised and bids were received on November 27, 1996, and are summarized below:

- The construction estimate is \$160,000.
- Civil Engineering Construction is the lowest responsible bidder and exceeded the M / WBE goals.
- Approval of plans and specifications and award to Civil Engineering Construction is recommended.

**FINANCIAL CONSIDERATIONS:**

- The project budget for the Sacramento River Docks Project A (KC11) is \$868,122.
- The project budget for the Sacramento River Docks Project Utilities (KC13) is \$213,000.
- The funding for this project was authorized in the 1994/1995 SHRA Capital Improvement Program between SHRA and the City of Sacramento and has been established under authority of City Agreement No. 83-003A.

**ENVIRONMENTAL CONSIDERATIONS:**

On April 6, 1995, SHRA filed a Notice of Negative Declaration with the County Clerk. The Negative Declaration, State Class 1 complies with Section 21108 or 21152 of the Public Resources Code. Mitigation measures were not made a condition of the approval of the project.


**POLICY CONSIDERATIONS:**

The action requested herein is consistent with Sacramento City Code, Title 58.

**WBE/MBE EFFORTS:**


Three of the bidders are certified with the City of Sacramento, two as WBE, and one as MBE. 6 of the 7 bidders exceeded the goals for subcontract participation. To encourage minority participation, plans and specifications were sent to 9 plan rooms and construction services organizations for publication. Four are directly involved with MBE/WBE construction firms. Staff actively recruited available MBE/WBE firms to participate in the bid process. The project was announced on the Project Information Line which contains information on Public Works and Utilities Department projects. Project notices were sent to 29 organizations involved in MBE/WBE recruitment.
