2. Adopt amendments to the Cable TV Franchise 20.0 and License 20.1 Ordinances regarding indemnity and insurance obligations of the SMCTC and its Franchisee and Licensees.

**SUMMARY:**

The Commission approved and recommended these changes updating the Cable TV Ordinances at its June 5, 1997, Cable Commission meeting. Since then, Commission Counsel coordinated review of the amendments with the City Attorney and County Counsel and the City Attorneys for Folsom, Galt, and Citrus Heights. AN ORDINANCE AMENDING SECTIONS 20.01.012, 20.01.030, 20.01.032, 20.01.036, 20.02.104, 20.01.105, AND 20.11.1012 OF THE SACRAMENTO CITY CODE AND ADDING SECTION 20.02.113 TO THE SACRAMENTO CITY CODE, TO PROVIDE REPRESENTATION ON THE BOARD OF DIRECTORS OF THE SACRAMENTO METROPOLITAN CABLE TELEVISION COMMISSION FOR THE CITY OF CITRUS HEIGHTS AND OTHER FUTURE MEMBERS

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

## SECTION 1.

Sub-sections "d" and "t" of Section 20.01.012 of the Sacramento City Code are hereby amended to read as follows:

d. "Cities" - shall mean the City of Sacramento, the City of Folsom, and the City of Galt, each of which enacted the provisions of this title in identical form and did not adopt a resolution disapproving selection of the Franchisee under the Initial CATV Franchise pursuant to Section 20.03.202, in Chapter 20.03, and any city in Sacramento County incorporated after the date that the initial franchise was issued, which enacts this title in identical form, as this title exists on the date of enactment, and executes the agreement contained in section 20.01.112.

t. "Sacramento community" shall mean the entire geographical territory within the unincorporated area of the county and the corporate limits of the Cities.
