YOU ARE HEREBY ORDERED TO PAY to the City of Sacramento an administrative penalty in the amount of \$4,999.00. The penalty is imposed in connection with the following violations:


SCC8.96.270 Failure to obey a Notice and Order issued against the property ordering the repair or demolition to be commenced within 30-days issued 9-9-1999.

Payment shall be sent to the City of Sacramento at 915 I Street, Room 104, Sacramento, CA 95814 on or before 09-17-2000. The administrative penalty is a personal obligation, and failure to pay the penalty may result in the amount being made a lien and/or special assessment against your property, as well as other legal action to collect the penalty. If a judicial action is required to collect the penalty, the City will seek to recover its attorney fees and costs from you. This administrative penalty fee **does not** include any other code enforcement charges that may be applicable to this case. You will receive a separate bill for any and all additional charges in this matter when the case is closed.

YOUR RIGHT TO APPEAL

You may appeal the imposition of this administrative penalty **within 20 calendar days** after the date this order is served by filing with the Office of the City Clerk a written notice of appeal and paying a non-refundable appeal fee in the amount of \$250.00. **If you fail to appeal, this order shall be final.** Any responsible party who files an appeal may seek review of any order entered as a result of the appeal pursuant to California Code of Civil Procedure Sections 1094.5 and 1094.6.
